#### A. Brief description of proposed change

The Department of Interdisciplinary, Gender, and Ethnic Studies has voted to change the structure of its various B.A. programs, by creating one umbrella B.A. in Interdisciplinary Studies, with separate tracks for the underlying majors in specific areas. The current individual degrees would be eliminated.

#### B. Justification for proposed change in existing academic program

This consolidation of majors will eliminate NSHE concerns about low-yield programs, while also strengthening the existing majors in a sense of solidarity, purpose and outcomes. The enrollments in each current major match national trends, but the department recognizes the benefits of combining smaller programs into one larger degree with options for specialization. Faculty also feel that by offering one broad degree with options, more students will become aware of the various areas of specialization through consolidated marketing and recruiting. Department faculty thoroughly and carefully discussed the implications of this change, and have presented the following rationale:

- Interdisciplinarity is the intellectual tradition and approach that unites all the various programs in the unit, both pedagogically and in terms of faculty and student research.
- The fields of Gender and Sexuality Studies, African American and African Diaspora Studies, Asian and Asian American Studies, and Latinx and Latin American Studies are historically, and by design, inherently interdisciplinary in that they draw on and aim to integrate insights from a wide range of academic disciplines, including but not limited to history, sociology, English, communication and media studies, anthropology, folklore studies, and more.
- This disciplinary integration is part of IGES's core academic mission and identity, hence the existence of the word "Interdisciplinary" in the name of the department.
- "Interdisciplinary Studies" is also the degree name that was in place when the separate degree programs were initially consolidated under one program header and, eventually, one department.
- Department faculty envision their department will continue to be a hub of interdisciplinary collaboration, cross-pollination, and community-based and creative scholarship and teaching, and see their faculty as campus leaders in these endeavors.

## C. Relationship to other programs or units within the institution and system

Most College of Liberal Arts departments at UNLV have one single major at the undergraduate level. With this change, the department will have a similar structure. In that regard, the current 'odd man out' situation will be modified to one of cohesiveness. Faculty believe this is a healthy, and forward-looking step.

Resources currently exist for each degree and will continue to be used for the consolidated degree.
