Good morning,

My name is Chris Boline and I am a two-time alumnus of the University of Nevada, a proud member of the Nevada Sagebrush (former EIC), and also a member of both the College of Business Alumni Association (where I was president) and the Sagebrush Alumni Chapter.

The field house project is a chance to leave a lasting legacy on this campus. I was part of the initial conversations back in 2013-14 when a student fee was passed to create the field house and fitness center and wrote an op-ed in favor of both at the time. The fitness center was of course completed and is a tremendous facility and whenever I bring alumni who are sponsors or prospective sponsors back to campus, they love seeing the growth of their alma mater. Additionally, I remember sitting in your shoes having a similar thought of not being able to use the fruits of that credit fee labor, but I can assure you that all of my peers from when I was in undergrad are incredibly proud of their alma mater's growth over the last 15 years. Also, looking back on that student fee being passed clearly has had an impact on the university as the entire gateway to campus is just awesome to behold.

As noted in this presentation, we lag behind UNLV and our MWC peers in having significantly lower athletics fees (\$2.867 million per year) than UNLV students (\$5.697 million). In fact, Nevada's student fees for athletics are the third lowest in the MW and around

half the conference average. The bottom line is we need more overall support to compete with other institutions the same way our teams compete on the field or court.

This is a project that has been talked about for decades and we are finally close enough to getting this accomplished with your help. The Wolf Pack has always punched above its weight during its entire history as an athletic department and I am fired up to see how we can do on a more level playing field.

When she was only 22 years old, pneumonia took my sister. There weren't any words to be said, only hugs to be given and tears to be shed. I of course took some time with my family but needed something to take my mind off things. For this I turned to Coyote baseball to escape this world that couldn't be real. I had already received messages from our entire coaching staff checking in on me and I received further support when I was back at the field. My first day back Coach Garritano called me into his office to share some helpful advice. I remember he told me that I had his full support in anything I needed. The only thing I could think of was pitching in our weekend series which he made sure of would happen. My family got to watch me pitch that weekend and for those three outs, nothing else mattered. They didn't have to think about the tragedy we suffered, they just got to watch their son play the game he loves at the school he loves to play it at. That's what CSN baseball is to me. It's not just nine players taking a field, it's a family that I turn to in the darkest of times. It's a team my family can watch when everything isn't sunshine and rainbows. They have been there for me through more than this comment can discuss. CSN produces great players, but if there's anything the coaches have taught us, family comes first and they epitomize that

above all else. Please let CSN reach others the way they have me for years to come by implementing this three dollar fee increase.

Comment:

Significant student fee increases are being considered in agenda items 22-26. Nobody likes raising student fees. However student fees are necessary, given limited state funding. Inflation in the costs of providing services and programs means that fees must be adjusted from time to time. As the elected fiduciaries of the higher education system, it falls on you as the Board of Regents to make these hard decisions.

An important context is that our overall student fees and tuition are quite low compared with other states. Because state funding is also below average, NSHE's overall revenue per full-time-equivalent student is the very lowest among 50 states, according to the 2023 State Higher Education Finance report of the State Higher Education Executive Officers Association [https://shef.sheeo.org/wp-content/uploads/2024/04/SHEEO_SHEF_FY23_Report.pdf#page=29]. Our instructional budgets are very stretched limiting our ability to serve students. That doesn't mean every proposed fee should be approved, but there is room for some increases without harming our competitiveness.

I would suggest the following criteria and questions for judging individual student fee increases:

- 1) What is the benefit of the fee on its own merits?
- 2) Does the fee support a core mission of the institution?
- 3) Given a variety of needs and budget shortfalls, is this the best use of a fee increase?
- 4) Is the fee being charged appropriately? That is, to all students for a broad program or to a

specific course or discipline. On a per-credit basis versus a per-student basis?

5) Is this an existing program that needs to be maintained, or a new project that could be deferred?

6) Given the recent increases in registration fees, is now the time to place an additional burden on students?

That's an opportunity for dialog and resetting the relationship between the Regents and the Legislature. I hope we can take advantage.

The NFA opposes agenda item 11. Tenure is not an absolute right of continued employment, but the termination of a tenured faculty member for cause must follow full due process. By removing the step where the full Board reviews the appeal of a termination and putting it in the hands of one person, this proposal short circuits the diversity of perspectives from the full board on a decision that could end an individual's career or damage an institution's reputation. Due process should not be sacrificed for expediency.

The well-established standards of academic freedom and tenure that are the hallmark of the American higher education system are outlined in the 1940 Statement on Principles of Academic Freedom and Tenure, a joint statement of the American Association of University Professors and the American Association of Colleges and Universities. The 1940 Statement establishes that it is the responsibility of the governing board, not an executive officer, to review these appeals and consider arguments from both sides. As for most leading colleges and universities, our regulations in chapters 6 and 8 of the NSHE Code are based on these principles in the 1940 Statement. The governing board's role should be maintained.

We ask you to reject this proposal.

Finally, the NFA supports agenda Item 12. Inflation adjustments to starting salaries are critical to ensure we can attract and keep the most qualified candidates.

I have been involved with the Wold Pack Marching Band as a performer or staff member since 2017. In that time, I've rehearsed in snow, rain, smoke, extreme wind, freezing cold, and high heat. When the conditions were determined to be too severe, the ensemble was forced to either cancel/shorten our practices or move indoors. The only indoor spaces suitable and reliably available for 130+ musicians has been Nightingale Hall or, more recently, the larger rooms in UFA or CFA. These spaces allow for music rehearsal, but are not conducive to the marching part of the activity. Specifically in 2021 during excessive wildfires in our area, we lost around a full month of field marching time, which was sorely needed coming out of the Covid-19 restrictions on large ensemble meetings. Another condition impacting the success of the band is extreme temperatures. Our area experiences freezing temperatures and scorching ones during the span of the marching season. We start our year in early August, learning a full pregame show and parts of halftime shows on a painted over parking lot at the north end of campus. It regularly reaches high 90°-100°+ during the middle of the day, forcing us indoors between 11am-6pm during band camp. This limits the marching instruction that can be provided. In the back half of the season, we frequently truncate practice for extreme cold, snow, wind, and rain. Any of these conditions could damage instruments and pose a hazard to student health. The use of an indoor fieldhouse would give us better quality and quantity of instruction and allow us to produce the best product possible for our audience. This would also allow our program to be on par with other schools such as Colorado State or Boise State.

Funding a development that would thusly benefit the ensemble and university I've spent my entire adult life representing is a worthy use of my student fees.

My name is Evelyn Airam and I am a Graduate Assistant here at UNLV in the School of Integrated Health Sciences and an organizer with Nevada Graduate Student Workers-UAW.

I'm here to talk about the major challenges that GAs experience in terms of our pay and workloads. While the GAs handbook stipulates that GAs only work 20 hours a week and are paid half-time, the reality is that many GAs are expected to work far beyond that. As Graduate Assistants, we all make well below what we need to afford groceries, housing, and other basic expenses, but some of us earn substantially less per hour because of uneven expectations and lack of workload protections. I know I am not the only one who sells my blood plasma to make ends meet, and I have colleagues who can't even do that because they are expected to be working in the lab nights and weekends. Though we know the cost of living is a serious challenge, we also know there are many needed changes to GA working conditions that would not come at a high cost to NSHE. Through our union, we are looking forward to advancing equity by creating clear workload protections so that no one is forced to do more work for less pay. Changes like this would go a long way in supporting our mental health, performance, and ability to fulfill the university's mission to serve our communities.

My colleagues and I have described just a few of the issues that GAs have reported in the hundreds of conversations that have happened during our campaign and affect GAs in every

department across all campuses here in Nevada. GAs are interested in making reasonable improvements that can allow the University of Nevada to continue to recruit a diverse pool of top graduate students and increase its competitiveness as an R1 institution.
