B. INTERNATIONAL STUDENT FEE

The recruitment, admission and advising of international students represents a tremendous cost to the University of Nevada, Reno, and University of Nevada, Las Vegas. The logistical and administrative burdens of international students on the university are complex and expensive. Increased costs of international mailing, phone, facsimile, recruitment, specialized printing, translations and highly trained personnel forces the university to make difficult budgetary choices. These choices often leave international students short of receiving the proper levels of attention.

Because of the limited resources of the Admissions and International Student Office, the need for funding aimed directly at the international students is essential. These funds will be directly used to support programs pertaining to international students. Additionally, it is not proper to use funds dedicated to benefit university students as a whole, to support activities that benefit only international students.

International students will pay a semester International Student Fee. The revenue from this fee will be used to sustain enrollment functions in the Admissions, Graduate, and International Student offices, supporting <u>only</u> international students.

As a federally recognized Minority Serving Institution (MSI), an Hispanic-Serving Institution (HSI), and an Asian American and Native American Pacific Islander-Serving Institution (AANAPI), a large percentage of our student population are Pell-eligible, First Generation, and/or from minoritized groups. Promoting equitable student success and closing the achievement gap requires a comprehensive safety net of academic support, inside and outside the classroom. Without adequate student fee funding, we are unable to deliver leading edge academic support to all students in an equitable way that meets students where they are and provides custom, segmented care and services.
