### **Reporting Requirement from NSHE Handbook**

Title 4, Chapter 10, Section 2: Supplier Diversity Spending and Inclusion Policy

- The NSHE supports equal opportunity for minority-owned, women-owned, and other small disadvantaged business enterprises (MWDBE) to compete for contracts awarded by NSHE institutions. The NSHE encourages efforts to promote local businesses to compete for NSHE contracts. Additionally, the NSHE seeks to find opportunities for MWDBE and local business concerns to participate as subcontractors or Tier 2 suppliers in large contracts. A "Tier 2 supplier" or subcontractor is a supplier contracted for goods or services with the prime contractor, which may include, but is not limited to, MWDBE and local business enterprises.
- NSHE institutions shall report annually to the Inclusion, Diversity, Equity, and Access ("IDEA") Committee on Tier 2 supplier expenditures with MWDBE and local business concerns for prime contracts awarded by NSHE institutions that exceed \$1,000,000. The Vice Chancellor for Budget and Finance shall develop procedures defining the information that must be included in each report. (B/R 12/21)

## Definitions

### **Tier 1 Supplier** A Prime Contractor.

### **Tier 2 Supplier**

A supplier who is contracted for goods or services indirectly supporting the Prime Contractor. Commonly referred to as subcontractors.

### **Local Supplier or Subcontractor**

A business that is:

- Owned 51% or more by Nevada residents
- Headquartered in Nevada
- Employing a majority of Nevada residents

# Definitions

#### **Disadvantaged Business Enterprise (DBE)**

A business at least 51% unconditionally owned by socially and economically disadvantaged individuals (minorities or women) or a publicly owned business with at least 51% of its stock owned by such individuals, who also control its management and daily operations.

#### **Minority Business Enterprise (MBE)**

A business at least 51% unconditionally owned by one or more minority individuals or a publicly owned business with at least 51% of its stock owned by minority individuals, with management controlled by them.

#### Women-Owned Business Enterprise (WBE)

A business at least 51% unconditionally owned by one or more women or a publicly owned business with at least 51% of its stock owned by women, with management controlled by them.

## **NSHE Record of Supplier Diversity Classifications**


All NSHE Purchasing Offices utilize the Supplier Registration System (SREG), which allows suppliers to self-register and self-certify their diversity status. Suppliers have the option to select or deselect their classifications in certain areas, at any time.

## **NSHE Tier 1 Expenditures FY23 and FY 24**



- **Details:** Hosted every spring, this event's specific mission is to connect local businesses with local buyers



## **Annual NSHE Supplier Outreach Initiatives**

- Event: Nevada Small Business Development Workshops
- **Details:** Hosted Quarterly, Purchasing and Planning and Construction are invited to present information on doing business with NSHE, including project types and current opportunities. These workshops are designed for the planning and construction industry.
- Event: Institution and Supplier 1:1
- **Details:** Hosted as needed, each purchasing office provides one-onone support to suppliers. These sessions cover registration assistance as well as guidance on policies and processes.

## Tier 1 and 2 FY23 Report and Tier 1 FY24 Report

The final report for FY23 has been prepared. This report includes Tier 1 and Tier 2 reporting for each individual institution, the total amount spent with suppliers, their diversity classifications, and any applicable subcontractor spending.

Only Tier 1 reporting for FY24 is included. Tier 2 data for FY24 is still being surveyed.

### **Future State: Proposed BDR**

There is a current BDR being proposed to the Nevada Legislature in the 83rd session that will affect all NSHE institutions. The BDR proposes the following:

- RBDAC to be renamed as 'Nevada Business Advisory Council' and expand from just Clark County to include Carson City, Washoe County and Douglas County
- The Council would be responsible for impacting revisions to policy and procedure
- Set aspirational goals for diverse-owned businesses participation in public contracts, mirroring successful models such as the City of Indianapolis' 27% diversity business participation goal for contracts valued above \$50,000.
- Allocate sufficient resources to support the implementation and monitoring of diverseowned businesses; participation goals, including staff training, outreach efforts, and the development of tracking systems.



### Future State: Supplier Diversity, Outreach and Tier 1 and 2 Reporting Enhancement

- Enhance JP Morgan Chase PCard Reporting capabilities
- Create training materials system-wide, including videos and aids for registration and business opportunities
- Leverage existing collaboration between NSHE institutions to ensure consistent responses from suppliers across all entities
- Continue development on our system-wide procurement website
