# Jason Frierson: Key Achievements & Contributions Legal & Public Service Leadership

- First African American U.S. Attorney for the District of Nevada Nominated by President Biden and confirmed by the Senate.
- Led an office of 115 attorneys and staff, overseeing Criminal, Civil, and Appellate Divisions.
- Strengthened community engagement and partnerships with federal and local law enforcement agencies.
- Rebranded the U.S. Attorney's Office to restore trust and credibility with the judiciary and community.
- Ensured that the office **better reflects the diversity** of the community it serves.

- Served 10 years in the Nevada State Assembly, including 6 years as Speaker, becoming the first African American Speaker in Nevada history.
- Led bipartisan collaboration to pass landmark policies in criminal justice reform, education, and healthcare.

#### **Jason Frierson Bio**



For the past 2 ½ years, I served as the US Attorney for the District of Nevada after being nominated by President Biden and confirmed by the Senate as the first African American in Nevada history. In this role, I oversaw the Criminal, Civil and Appellate Divisions, as well as administrative staff in an office of 115 attorneys and staff. I made it a priority to have greater community engagement, improve partnerships with federal and local law enforcement agencies, rebrand the office in the eyes of the judiciary after years of declining perception from the bench, and worked hard to make sure, that the office better reflects the community it serves.

Prior to being confirmed as US Attorney, I practiced in civil litigation and family law, primarily negotiating domestic and international surrogacy contracts. For 15 years, I also worked on both sides of the criminal justice system, as a public defender and as

a prosecutor. Through the 2007 and 2009 state legislative sessions, I lobbied on behalf of Clark County on issues related to criminal justice policy, social services and utility provider matters. After lobbying, I was elected to serve in the Nevada State Assembly for 10 years, including 6 years as the Speaker of the State Assembly, the first African American in Nevada to do so.

In the Assembly, I wrote and passed several pieces of legislation, including policies related to elections, foster care, healthcare billing practices, housing foreclosures, workplace discrimination and harassment, public education funding, and policies expanding clean and renewable energy.

As Speaker, I developed a reputation for maintaining productive, collaborative working relationships across party lines both in the legislature and with the Governor. I also established a practice of meeting weekly with nearly every advocacy sector, including chambers of commerce, unions, progressives, law enforcement, insurance, healthcare, and local government.

I continue to actively engage in community service and am a member of Kappa Alpha Psi Fraternity Incorporated, the Las Vegas Chapter of the National Bar Association, and Sigma Pi Phi Fraternity. Some of my awards and honors include receiving the Barbara Buckley Leadership and Community Service Award, "Kappa Alpha Psi Leadership League and Jason Frierson Day," voted Best Freshman Legislator 2011, Nevada Justice Association 2018 Consumer Advocate of the Year and 2019 Nevada Press Association First Amendment Champion.

I grew up in Compton, CA, attended the University of Nevada, Reno (B.S., 1996) where I was leading the nation in rushing yards until I suffered a career ending knee injury. I served as ASUN President there before becoming a faculty member at the University of Nevada, Reno as Recruitment/Retention Coordinator. I then attended the William S. Boyd School of Law, University of Nevada, Las Vegas (J.D., 2001), where I also served as SBA President. My wife Abbie and I are the proud parents of our two children
