He currently serves on the Executive Committee of the Western Academic Leadership Forum, on Idaho's Council on Academic Affairs and Programs, and on the Alumni Board of Brigham Young University. He is also the Higher Education Lead for Idaho to the Smarter Balanced Assessment Consortium and Chair of the Wiki Education Advisory Board.

Please accept this letter of application and curriculum vitae for the position of Chancellor of the Nevada System of Higher Education. My laser focus on student success, demonstrated ability to bring people together to work toward shared decision-making, dogged advocacy for higher education, and unique expertise in senior administration and system policy make me well-qualified to lead NSHE into the future. As a native of the West, I have spent a lot of time in Nevada and want to be a part of ensuring its continued growth and development through a robust and well-utilized higher education system. I am prepared to work with you and the presidents, as well as with faculty, students, elected officials and the business community, to continue building a world-class system that draws people to Nevada, grows opportunities for learners to stay there, and enriches the lives of all its citizens. Here are some highlights of the attributes, characteristics, and experience I would bring to this important role:

A proven leader, recognized for unwavering integrity, ability to resolve difficult political issues with grace, and dedication to shared governance. My leadership philosophy consists of three principles: Honor agency. Invite accountability. Give compassion. Consistently implementing these principles creates a culture infused with hope and brimming with vision. These principles show up in the ways I lead complex, cross-institutional teams. They are particularly evident in the way my team and I lead academic, student, research, and multicultural affairs across the eight higher education institutions in Idaho. Our collaborative work with the presidents, provosts, research administrators, faculty, and broader community is a testament to the impact of these principles in operation.

A strategic thinker with demonstrable success in developing and implementing effective strategic plans in multiple organizations. As one example, I led the development and implementation of the William and Flora Hewlett Foundation's global strategic plan for open educational resources (OER). This plan, implemented over several years, led to massive increases in funding for OER in higher education in multiple states, demonstrable improvements in faculty pedagogy and student learning at hundreds of institutions, and international policy that requires all 193 countries to report on open education activities and impacts. I currently lead the strategic plan for the digital campus initiative known as Online Idaho. This system-wide initiative to increase access and affordability was developed in response to the pandemic and has required significant resilience and innovation in response to a dynamic situation.

Deeply committed to the ideas of systemness and collaboration for progress. I have effectively led cooperation across multiple institutions to create a whole greater than the sum of its parts. In my current role, I have facilitated significant change across all of Idaho's higher education institutions. In particular, our team has advanced priorities to establish a more system-like approach in a historically federated and competitive higher education landscape. From land-grant, to professional, to urban comprehensive, to technical education, to community college functions, Idaho's institutions have as many similarities as they have differences. They are as geographically dispersed as they can be, separated by vast distances, impassable mountain ranges, a time zone, and surprisingly deep cultural differences. Despite this complexity, I have successfully led multiple statewide initiatives, including establishment of a uniform learning management system, a co-admit/co-enroll agreement, a financial aid agreement, remediation reform, and a statewide online course sharing platform. I would leverage my deep, hands-on experience to connect more Nevada residents to the incredible value the system has to offer.

Strong political acumen, evidenced by productive and trust-based relationships with many elected and appointed political leaders at state, national, and international levels. I currently serve at the pleasure of an eight-member Board of Education appointed by the Governor. In this role, I work regularly with Board members, the Governor, executive agency staff, legislators, and institutional presidents to carry out the mission of the board and improve educational access, affordability, and success for all students. In particular, I led the Board's efforts to effectively respond to concerns raised by the legislature about the impact of campus climates on student learning and belonging. That year, the legislature provided record levels of funding for higher education in Idaho, despite cutting budgets the previous year.

I oversee a multi-million dollar budget focused on academic success initiatives and work closely with our chief financial officer to manage the entire postsecondary budget for the eight institutions in Idaho. We work with our statewide and institutional audit and risk teams to ensure appropriate controls, and we work with our board and institutional leaders to identify areas for strategic investment across the spectrum of instruction, research, student affairs, facilities, and athletics. I have successfully overseen the establishment of multiple statewide contracts for academic technology, and have supported our Board's efforts to establish similar shared services for other aspects of institutional operations. My capabilities with these fiscal matters, combined with my success in leading statewide initiatives related to instruction, research, and student affairs in Idaho, are evidence of my ability to meet your priorities for the next Chancellor.

My unique background and executive experience, not just in higher education, but in philanthropy and the non-profit sector on the global stage, have prepared me exceedingly well to be successful as the next Chancellor of NSHE. I am an **advocate and champion** of higher education.
