Matt McNair is a dynamic, results-oriented leader with a distinguished career spanning law, government, higher education, fundraising, and economic and workforce development. Beginning his career in the U.S. Navy JAG Corps, he later served as a Special Assistant U.S. Attorney in the Southern District of California and as a General Partner at a venture capital firm based in Santiago, Chile. He practiced corporate and securities law before serving as Chief Deputy Attorney General for the State of Nebraska.

Matt then moved into higher education where he led fundraising for the University of Nebraska – Lincoln and the Ohio State University College of Engineering, where his teams raised more than \$1 billion and completed two comprehensive campaigns. Matt next served as Vice President of Economic and Corporate Engagement at Ohio State, where he had campus-wide responsibilities for corporate relations, economic development, and technology commercialization at one of the largest and most complex college campuses in the country. He also served as the President of the Ohio State Innovation Foundation, and his team drove growth in corporate-sponsored research, licensing revenue, and startup creation while working closely with state and local economic development partners. He then served as President of the Oregon Health & Science University Foundation, where his team completed a \$2 billion comprehensive campaign supporting medical research, education, and patient care.

Currently, as President of Cardinal Advisors, Matt consults with institutions like the University of Alabama, the University of Michigan, and Nicholls State University, forging strategic alliances that enhance research, sponsorships, and philanthropy. Matt is also the founder and CEO of TrustLab, a nonprofit using evidence-based methods to rebuild community-police trust, underscoring his commitment to social impact and criminal justice reform. Last year Matt served as interim CEO of the South Carolina Technical College System Foundation, where he focused on workforce development innovations to fill gaps in South Carolina's workforce.

Matt has deep governance experience, serving on boards such as the Ohio State Innovation Foundation, University of Nebraska – Lincoln Alumni Association, Nebraska Bank of Commerce, Lincoln Electric System, Oregon Health & Science University Foundation, Doernbecher Children's Hospital Foundation, and Invest Nebraska.

Dear Search Committee Members,

I am pleased to apply for the position of Chancellor of the Nevada System of Higher Education (NSHE). With extensive experience in higher education leadership, strategic institutional growth, and public policy, I am eager to contribute to NSHE's mission of advancing student success, faculty excellence, and economic and community impact across Nevada.

NSHE has built a strong foundation in higher education, research, and workforce development. As a leader in university advancement, corporate engagement, and economic development, I understand how to position an institution for long-term success through strategic planning, multi-disciplinary collaboration, and financial stewardship. My career has spanned multiple senior leadership roles across academia, law, government, and philanthropy – each of which has prepared me to lead NSHE in the coming years.

LEADERSHIP IN HIGHER EDUCATION

I believe the best university leaders possess the vision, strategic thinking, management skills, and political acumen needed to lead any large, complex organization, while embracing the unique culture and mission of academia. Over the past two decades, I have led and advised large universities in key areas such as fundraising, technology commercialization, and corporate relations. I have had campus-wide responsibilities at universities with significant athletics programs and medical centers.

As Vice President for Economic & Corporate Engagement at The Ohio State University, I led corporate partnerships, economic development, and technology commercialization. Under my leadership, Ohio State set new records in licensing revenue and startup creation, establishing the university as a national model for university-industry collaboration, evidenced by Ohio State's very strong record in corporate sponsored research.

As President of the Oregon Health & Science University (OHSU) Foundation, I led an organization managing a \$1.1 billion endowment, and completed the \$2 billion ONWARD

campaign during the challenges of the COVID-19 pandemic. I have extensive experience aligning institutional goals with state and national priorities, securing funding, and fostering public-private partnerships that enhance institutional sustainability and impact. I would welcome the opportunity to discuss how I would apply my experience and insights to provide stability to NSHE, maintain a strong financial foundation, and effectively implement the goals and directives of the Board.

GOVERNANCE, POLICY, & LEGAL EXPERTISE

Understanding and navigating the complexities of higher education governance is critical to the Chancellor role. I have reported directly to a governing board and several university and corporate advisory boards, successfully implementing strategies that align institutional priorities with stakeholder expectations.

My experience as Chief Deputy Attorney General of Nebraska gave me deep insight into state government operations, legislative processes, and legal affairs. I worked in the state capitol for five years, working closely with the Governor, his Chief of Staff, agency directors, and legislators, on a wide variety of legal and policy issues. I have also worked extensively with state and federal leaders to advocate for higher education funding, workforce development initiatives, and university research priorities. This experience will be of great value as NSHE navigates evolving policies affecting higher education. Recent announcements by the federal government that impact higher education highlight just how relevant my experience in law and politics will be as higher education leaders navigate a new and challenging environment.

COMMITMENT TO STUDENT & FACULTY SUCCESS

A university's most important mission is student success and faculty empowerment. I have created programs that enhance student engagement, workforce readiness, and career pathways such as internship and cooperative education initiatives that connect students with real-world opportunities.

I also understand the importance of faculty governance, academic freedom, and tenure, ensuring that universities foster environments where teaching, research, outreach, and innovation thrive. Strong faculty leadership is essential, and my experience in higher education has taught me that collaborative decision-making, multi-disciplinary research, and shared governance are powerful tools that enhance the impact of the university.

Universities are among the leading organizations that must provide a platform for free inquiry to ensure that the marketplace of ideas will continue advancing the human condition. Diversity of every kind should be valued in a university setting – racial, economic, political, ideological, etc. The best way to defeat bad ideas is with good ideas, and no person or group has a monopoly on

good ideas. I believe in using a growth mindset to ensure a culture of respect, professionalism, and belonging.

ALIGNING HIGHER EDUCATION, BUSINESS, & COMMUNITY NEEDS

Higher education plays a pivotal role in economic development. My leadership at institutions like The Ohio State University, the University of Nebraska, and Oregon Health & Science University has focused on bridging the gap between academia and industry to ensure that universities are producing the workforce and research that drive regional and national economies. These experiences have reinforced my belief that higher education should be responsive to student and industry needs—a vision that I would champion as NSHE Chancellor.

In my role as interim CEO of the South Carolina Technical College System Foundation, I learned a great deal about workforce training initiatives, particularly among underrepresented groups, and how to address labor market shortages and attract and retain businesses in the state. I believe NSHE has a unique opportunity to build on the impressive trajectory of economic and population growth that Nevada has experienced by designing coordinated strategies to deliver the workforce that the private sector needs.

The NSHE Chancellor will bring people together to agree on common goals and priorities, but not everyone will agree on the methods or resources needed to accomplish those goals. Bridge building skills will be critical for the new leader. I utilized many of these skills as an attorney and as a fundraiser. I learned profound lessons about bridge building when I founded TrustLab, a 501(c)3 with the mission to heal the relationship between police and marginalized communities. I have worked closely with the founder of Braver Angels and with the President of the National Unity Council in Rwanda, who have taught me a great deal about how to bridge divides. These same principles apply to any divide, whether red/blue, rural/urban, or any other.

A VISION FOR THE FUTURE OF NSHE

The next NSHE Chancellor must be a unifying leader who brings together faculty, students, business leaders, policymakers, and communities, and projects strength and stability. I have spent my career strengthening partnerships and creating solutions by listening to understand, charting a course that accounts for the perspective of all interested parties, communicating clearly, and executing plans with transparency and accountability.

NSHE's *Success by Design* strategic plan lays out a clear vision for expanding access, enhancing student outcomes, and driving economic development. My experience improving student access to professional opportunities, implementing workforce development programs, making university research more accessible, and recruiting national and international companies directly aligns with these priorities.

If selected, I would focus on:

- Expanding student success initiatives that enhance workforce readiness and economic mobility.
- Strengthening faculty and research excellence through targeted investments and policy support.
- Enhancing corporate partnerships and public-private collaborations to drive NSHE's role in regional economic development.
- Advocating for NSHE at the state and national level, ensuring strong relationships with policymakers and funding agencies.

I am excited about the opportunity to serve as NSHE Chancellor, and I am confident that my experience, leadership, and commitment to higher education will bring value to the system and the state of Nevada.

I am eager to further discuss how my background and vision align with NSHE's mission and goals. Thank you for considering my application. I look forward to the opportunity to contribute to NSHE's continued success and growth.
