Good morning, Regents, Chancellor, Presidents, and members of the public. My name is Giovanni Jones, and I am here today as a student who is deeply engaged in this system and deeply concerned about the proposed fee increases.

I want to begin by acknowledging the fiscal reality presented in the Board materials. I understand that the Nevada System of Higher Education received one-time bridge funding through AB 568, and that this funding expires after FY27, creating a significant shortfall that institutions must resolve to avoid major operational gaps. I also recognize that our system is still below the national average in total revenue per student, especially in tuition, and that NSHE has historically prioritized affordability,

But today, I want to speak to the student perspective, because affordability is not an abstract concept it is lived reality. The proposal before you ask students to pay more, year after year, not because they are getting more, but because the System must backfill a funding gap created by previous decisions. For students, this feels less like an investment and more like a shift of responsibility.

When we talk about predictable pricing, predictability must apply to students not just institutions. The proposed increases of 3%, 4%, and 5% at our universities, and 2%, 3%, and 4% at our colleges, may seem modest on paper, but the cumulative impact is real, especially for first-generation, low-income, and working students. Students are not asking for more debt, and they are not asking to subsidize state funding shortfalls. BRING BACK HEY REB MASCOT

The Rebels nickname at University of Nevada, Las Vegas traces back to a regional rivalry with the University of Nevada, Reno—where red (south) symbolically "rebelled" against blue (north) at University of Nevada, Reno. In the late 1960s and early 1970s, the original UNLV mascot reflected that symbolism and was styled like a generic Southern Civil War—era figure, which over time became informally associated with a Confederate soldier—though it was meant to represent rebellion, not the Confederacy itself.

In 1983, UNLV intentionally replaced that imagery with Hey Reb!, a complete re-design created to remove Confederate associations. Hey Reb was depicted as a cartoonish, Old West outlaw / Las Vegas—style gunslinger, inspired by frontier and Wild West themes—not the Civil War. He wore no Confederate uniform, carried no political symbolism, and was designed purely as a spirit mascot reflecting Nevada's frontier culture and Vegas personality.

In short:

- The Rebels name came from a north–south rivalry, not an endorsement of the Confederacy
- The earliest mascot did resemble a Civil War-era Southerner, which later drew criticism
- Hey Reb was explicitly not a Confederate soldier and was created to separate UNLV from that imagery altogether

That distinction—name vs. imagery—is the key historical nuance many people miss.

Firstly, I'd like to thank the University of Nevada Las Vegas for your hospitality in hosting a screening and panel discussion surrounding our documentary film Imagining The Indian: The Fight Against Native American Mascoting just this November. We were glad to be back in Southern Nevada, where we have visited several times for interactive community screenings. In the film we highlight the fact that team names and mascots that are steeped in traumatic histories have very real and tangibly harmful consequences – not only to those historically affected, but to all of us. Decades of social science research has proven that these team names, mascots, and the behaviors they accommodate and encourage, amount to a crisis of public health. It is indeed a matter of fact, not a matter of opinion. We have screened the film in hundreds of places, many of them schools and universities, some that have undergone athletic re-branding and some that are having discussions about doing so. We have developed a curriculum in partnership with PBS Learning Media and the National Indian Education Association in an effort to educate people about the damage a mascot can do. I applaud UNLV for having moved on from Hey Reb! and its Confederate roots, and urge the institution to consider what might unify rather than divide as you contemplate a path forward. A bringing together of people is, after all, what a mascot is designed to do.

The University of Nevada, Las Vegas should strongly consider bringing back Hey Reb! as its mascot, not as a symbol of division, but as a celebration of the true history and spirit that originally inspired it. When the school, then known as Nevada Southern University, sought independence from the University of Nevada, Reno in 1955, students selected Beauregard as the first mascot. Although intended as a playful counterpart to UNR's fierce wolf, concerns understandably grew over time that Beauregard's Confederate imagery did not reflect the values or history of the Las Vegas community.

That shift opened the door to a new identity. In 1982, local advertising partner Mike Miller helped reimagine what a Rebel could truly represent. Drawing inspiration from the mountain men of the 1800s, Miller envisioned a figure rooted in Nevada's authentic past, not the Confederacy. These rugged pathfinders were fiercely independent explorers who mapped trails, prospected for resources, and built the foundations of many early Western communities. Their legacy is still evident today in the very streets of downtown Las Vegas, bearing names like Carson, Ogden, Bonneville, and Lewis and Clark.

Hey Reb! was created to honor this frontier spirit—one defined by exploration, resilience, and the courage to forge a new path. Restoring the mascot would reconnect UNLV with the original intent behind its Rebel identity: celebrating the pioneers who shaped Nevada's history, not the symbolism that never belonged to the community in the first place.
