The Board of Regents shall select the student member from a list of names submitted by each NSHE institution. Each institution of the NSHE may submit up to three names, as decided by each institution" (language taken from Committee Work Session Document, available online). Work on this proposal was originally undertaken by ASUN. An update will be provided by ASUN Chair Huili Weinstock.
