#### **NEVADA STUDENT ALLIANCE – PUBLIC COMMENT**

Thursday 11 June 2020

The following statement, to be read into the public record, on behalf of:

Stephanie Molina, President of the Graduate and Professional Student Association

The state of Nevada defines a "public officer" as a person elected or appointed to a position that is established by a statute of the state. As publicly elected officials, student body presidents are state public officers given that Nevada Revised Statute 396.547 establishes student governments for each branch of the Nevada System of Higher Education. Furthermore, this statute provides our organizations with self-governance and full independence from institutional administration and oversight. The state intended for us to be able to exercise administrative discretion in the formulation of policy, expenditure of public money, and administration of these public bodies with the authority set forth in our bylaws.

However, administrations will interfere when student governments create policy that does not reflect their directives, and obstruction, as defined by state statutes, of public officers ensues.

Presently, UNLV is violating Nevada statutes without oversight by interfering and obstructing with my ability to perform my official duties as a public officer of the GPSA. They have threatened academic sanctions and they have already inhibited my educational opportunities, including those afforded as a result of student government, such as running for NSA office.

A third term presidency is not common within our student government associations. Rather than allowing me to continue to effectively administer my association per Nevada statutes, UNLV has undertaken an investigation against me that is out of their jurisdiction (both by UNLV, NSHE, and DOE standards) into my personal life while utilizing false evidence that an employee submitted to the institution. Most recently, UNLV has invaded my privacy by demanding thirty thousand pages worth of personal communications not subject to NRS. Moreover, they have failed to provide me with twenty-six months, and counting, worth of remuneration.

As such, I am encouraging each and every one of the Nevada Student Alliance members to revise your individual bylaws and constitutions to reflect this Nevada statute that prohibits institutional oversight. Furthermore, the NSA must spearhead this change within its own constitution as a leader for all student governments.

Finally, as the chief executive of the GPSA, currently being unable to administer my organization freely from system administration as per NRS, I am requesting the removal of the GPSA from membership in the NSA, effective immediately, until further notice from me.

# 3. DISCUSSION WITH BOARD OFFICERS AND CHANCELLOR <u>INFORMATION</u>

Student representatives will have the opportunity to have an open dialogue with members of the Board of Regents and Chancellor. The discussion will include student experiences, concerns of their constituents, and other matters related to their roles in student government. Chancellor Reilly introduces himself and entertains the open dialogue with student representatives.

Chair Gabrielle Clark asks Chancellor Reilly about tuition increase regarding medical departments at UNLV and UNR.

Chancellor Reilly says that it will increase 3% each year.

Chair Gabrielle Clark mentions that the Student representatives held their first meeting earlier in the day.

Chancellor Reilly informs Student representatives that we can be recognized to ask questions/make comments during agenda items at Board of Regents meetings.

Chancellor Reilly informs Student representatives that the Board will discuss the budget (additional 5% budget reduction plan) that Gov. Sisolak requested during tomorrow's Board meeting. He also mentions that they are recommending that the Board extract the funds from an investment pool, which will be another \$35 million being taken from investment pool. Depending on the contribution made by each institution, UNR, UNLV, TMCC, and Desert Research Institute will receive a small percent more than they made during cuts because of the losses they have had.

Chancellor Reilly mentions the request of Gov. Sisolak to hold a special session of the Legislature to discuss furloughs and all proposals for FY 2021.

Chief of Staff, Michael Flores states Student representatives' and student voices and engagement are critical to make sure Legislatures and Governor's office are aware of our concerns and needs.

Chair Gabrielle Clark asks if Student representatives should collectively meet to address Legislature issues.

Chief of Staff, Michael Flores advises that each institution should strategically speak to Legislatures in their district/area.

Chair Gabrielle Clark entertains scheduling a meeting with Chief of Staff, Michael Flores, to further discuss strategies to connect with Legislatures and address concerns.

Chair Gabrielle Clark asks Chair Geddes if he can inform students and Student represents about campus police activities and their policies, so students are aware of law enforcement rules/policies around campus communities.

Chair Geddes states that Chief Garcia and Chief Renwick are scheduled to speak during the September Board meeting to present their policing policies; and, a staff has been asked to look at potential policy changes to Board. He also asks Student representatives to submit any requests to our Chancellor, Chiefs, or Board members so they are mentioned during the September meeting.

#### **NEVADA STUDENT ALLIANCE – PUBLIC COMMENT**

Thursday 11 June 2020

The following statement, to be read into the public record, on behalf of:

Stephanie Molina, President of the Graduate and Professional Student Association

The state of Nevada defines a "public officer" as a person elected or appointed to a position that is established by a statute of the state. As publicly elected officials, student body presidents are state public officers given that Nevada Revised Statute 396.547 establishes student governments for each branch of the Nevada System of Higher Education. Furthermore, this statute provides our organizations with self-governance and full independence from institutional administration and oversight. The state intended for us to be able to exercise administrative discretion in the formulation of policy, expenditure of public money, and administration of these public bodies with the authority set forth in our bylaws.

However, administrations will interfere when student governments create policy that does not reflect their directives, and obstruction, as defined by state statutes, of public officers ensues.

Presently, UNLV is violating Nevada statutes without oversight by interfering and obstructing with my ability to perform my official duties as a public officer of the GPSA. They have threatened academic sanctions and they have already inhibited my educational opportunities, including those afforded as a result of student government, such as running for NSA office.

A third term presidency is not common within our student government associations. Rather than allowing me to continue to effectively administer my association per Nevada statutes, UNLV has undertaken an investigation against me that is out of their jurisdiction (both by UNLV, NSHE, and DOE standards) into my personal life while utilizing false evidence that an employee submitted to the institution. Most recently, UNLV has invaded my privacy by demanding thirty thousand pages worth of personal communications not subject to NRS. Moreover, they have failed to provide me with twenty-six months, and counting, worth of remuneration.

As such, I am encouraging each and every one of the Nevada Student Alliance members to revise your individual bylaws and constitutions to reflect this Nevada statute that prohibits institutional oversight. Furthermore, the NSA must spearhead this change within its own constitution as a leader for all student governments.

Finally, as the chief executive of the GPSA, currently being unable to administer my organization freely from system administration as per NRS, I am requesting the removal of the GPSA from membership in the NSA, effective immediately, until further notice from me.
