**A RESOLUTION IN SUPPORT OF RECOGNIZING
MAJOR JEWISH HOLIDAYS ON THE CALENDARS OF
NSHE INSTITUTIONS**

1 **Whereas**, the Nevada Student Alliance represents all 100,000+ students in the Nevada System of
2 Higher Education;

3 **Whereas**, the Nevada Student Alliance is comprised of elected representatives from all
4 NSHE institutions whose numerous responsibilities include voicing and lobbying student concerns
5 to their elected officials in local, state, and federal levels;

6 **Whereas**, there are a reported number of Jewish students at half of NSHE institutions such
7 as¹:

- 8 • 150 Jewish students at the University of Nevada, Reno.
- 9 • 750 Jewish students at the University of Nevada, Las Vegas.
- 10 • 10 Jewish students at Western Nevada College.
- 11 • 25 Jewish students at Truckee Meadows Community College.

12 **Whereas**, the Associated Students of the University of Nevada, Reno passed Senate
13 Resolution 88 “*A Resolution in support of recognizing Jewish Holidays*”;²

14 **Whereas**, important Christian holidays are recognized by all NSHE institutions and grant
15 some time off for students and staff;

16 **Whereas**, the Nevada System of Higher Education’s Title 4 Codification of Board Policy
17 Statements has a policy which states “It is the **policy** of the **NSHE** to be sensitive to
18 the **religious** obligations of its students. Any student missing class, quizzes, examinations or
19 any other class or lab work because of observance of **religious** holidays shall, whenever
20 possible, be given an opportunity during that semester to make up the missed work.”³

1 *Whereas*, NSHE gives the discretion of the individual professors to allow classwork to be
2 made up;

3 *Whereas*, NSHE professors may not be accommodating to granting extra time for
4 assignments missed due to the practice of prominent Jewish Holidays.

5 *Whereas*, the United States Bill of Rights' first amendment, through the Free Exercise
6 Clause, allows for the freedom to practice religion;

7 *Whereas*, Jewish Holidays are not recognized by NSHE;

8 *Whereas*, Jewish students have a hard time using their first amendment rights to practice
9 their religion;

10 *Whereas*, the Supreme Court in 2003 did not meet because the Supreme Court was meant
11 to commence on the date of Yom Kippur and set a precedent to not meet on Yom Kippur⁴

12 *Whereas*, Yom Kippur and Sukkot days 1 and 2, are during the Fall semester;

13 *Whereas*, instructors at all NSHE institutions should be accommodating to the religious
14 practices of their students whose holidays are not accommodated in the NSHE calendar,
15 starting with prominent Jewish Holidays;

16 **THEREFORE, BE IT RESOLVED**, that the Nevada Student Alliance, on behalf of the
17 100,000+ students of NSHE:

- 18 • Supports the recognition of prominent Jewish holidays on the calendars of NSHE
19 institutions: AND
- 20 • Urges the Board of Regents to discuss implementing or advocating for the recognition of
21 Jewish holidays for NSHE institutions.

**A RESOLUTION IN SUPPORT OF MAKING ELECTION DAY A STATE
HOLIDAY**

1 **WHEREAS**, the Nevada Student Alliance represents all 100,000+ students in the Nevada System
2 of Higher Education; and

3 **WHEREAS**, the Nevada Student Alliance is comprised of elected representatives from all NSHE
4 institutions whose numerous responsibilities include voicing and lobbying student concerns to
5 their elected officials in local, state, and federal levels; and

6 **WHEREAS**, a large population of the 100,000+ students are eligible voting citizens that can
7 participate in State and Federal elections; and

8 **WHEREAS**, a large majority of the faculty, staff, and administrators that make up the Nevada
9 System of Higher Education are also eligible voting citizens; and

10 **WHEREAS**, the Nevada System of Higher Education follows the holiday calendar set forth by
11 the Nevada legislature in NRS 236.015; and

12 **WHEREAS**, every year on Election Day (the Tuesday after the first Monday in November),
13 millions of Americans do not have the opportunity to vote due to obligations to work, school, or
14 other public responsibilities; and

15 **WHEREAS**, multiple states including Delaware, Hawaii, Illinois, Kentucky, Louisiana, Montana,
16 New Jersey, New York, Ohio, Virginia, West Virginia, and the territory of Puerto Rico have
17 election day as a state/civic holiday; and

1 **WHEREAS**, a coordinated advocacy campaign from the Nevada System of Higher Education to
2 the Nevada State Legislature could benefit all students, staff, faculty, administrators, and the
3 greater community in practicing their guaranteed right to vote.

4 **NOW THEREFORE, BE IT RESOLVED**, that the Nevada Student Alliance, on behalf of the
5 100,000+ students of NSHE:

6 • Supports the initiative that every election day be designated a State holiday in Nevada;
7 AND

8 • Urges elected student representatives of the Nevada System of Higher Education to
9 actively pursue resolutions from their institutions in regards to supporting Election day to
10 be a Nevada State Holiday; AND

11 • Urges the Board of Regents and Chancellor of the Nevada System of Higher Education to
12 work to advocate the Nevada Legislature to pass Election Day as a Nevada State holiday.
