"Hello and good morning. As president Stanfill said, my name is Amanda Vaskov I am a student at UNR I have the pleasure as serving as the director of government affairs for our associated students at the university of Nevada. It is such a pleasure to be here at this NSA meeting this morning. I am here to just show my support for an NDSA agenda item today regarding access NSA access to the NSHE Board agenda. This is something that I care deeply about when it comes to representation of student interest within government. Currently as it stands the Nevada student alliance does not have access to recommendations to the agenda that the chair can put on. This resolution if passed by NSA would change this hopefully. So long as it would get on the next board agenda and remove the structural barrier that exists to student representation within NSHE. So I would like to thank you all, for NSA, for being representatives of all Nevada Students and I hope that you consider increasing and amplifying your own voice by passing this resolution. So thank you so much."

"Hello and good morning to you all. For the record my name is Dayton D-A-Y-T-ON Vasquez V-A-S-Q-U-E-Z. My public comment today is in regard to the comments made by chair Dionne Stanfill during the Board of Regents meeting that took place on September 9th, 2022. Chair Stanfill made comments that were not only disrespectful, but unnecessary towards Nevada State College. These comments were not agreed upon by the Nevada Student Alliance. And by Chair Stanfill using her position as chair to make remarks on behalf of NSA, that is wrong and not justifiable. In her remarks she claims that UNR is a "university for all." With a university population that is well over 50% white and with the highest tuition costs in the state, you claim to be a university for all, I claim you to be a university for the rich, powerful, and white. And the undergraduate student body president as well as the university president very well represent and fit that narrative. Chair Stanfill also points out in her statement the high native population. However what Chair Stanfill did not mention was how UNR's alumni has historically been hurting and screwing over the indigenous people of northern Nevada in the legislature for decades and they continue to do it now. I am a proud student at Nevada State College and there is nothing that can change that. I must remind us all, that there is no competition between us. We are all here for the same reason, to serve and represent the students at our own institutions. And when you consider something as simple as a institution name change as "competition", then you lose the interest of who you serve. Chair Stanfill's comments during the Board of Regents meetings will be tolerated, and for her to tell Nevada State College to stay in our lane, I tell her no. Thank you for your time."

9:14 am Kevin – Public comment about Chair Stanfill's comments from the September Board of regents meeting, during the discussion regarding the Nevada State College proposed name change.

"For the record, Kevin Osorio Hernandez,
I want to use this time to address the comments made by UNR
Student President Dionne Stanfill during the September Board of
Regents meeting on the agenda item to rename Nevada State

College, Student President Stanfill had much to say during her comments on Nevada State's name change. In her comments, she said, "this name change promotes the stigma of attending a community college." Student President Stanfill, thank you for blindly supporting the premise of why we seek a name change. Nevada State is not a community college, and you so blindly mention part of the reason for our name change. So I thank you for your blind support. In addition, Student President Stanfill says, "There should be no need to validate your education." How dare a privileged person say such a disgusting comment knowing that Nevada State serves our high population of underserved minorities. Her remarks were microaggressive, making it clear to me that the white lady does not understand the needs of the new majority. I am part of a system that was not intended for me to succeed. The white lady does not get to tell me what I need to validate; my education is the last thing I need to validate. Then Student President Stanfill says, "UNR... is accessible, diverse and opportunistic." I laugh at that. How is UNR diverse? According to UNR stats, 52% of students are white, only 22% are Hispanic, 4% are black, and 8% are Asian. Nevada State flips those numbers where 48% of students are Hispanic, 24% are white, 8% are Asian, and 7% are black. How is UNR accessible and opportunistic? Nevada State serves and gives more opportunities to the underserved population in our state. From the single mother who has to work three jobs to the first-generation college student who cannot afford to move north to a new city. Nevada State is genuinely the true institution of accessibility, diversity, and opportunity. Do not underestimate Nevada State."

"Good morning. For the record, my name is Amiyah Henly (A-M-I-Y-A-H H-E-N-L-Y). Today my public comment pertains to remarks made by NSA Chair Stanfill during the Board of Regents meeting on September 9th, 2022. Make no mistake, I am proud to be a scorpion, and will say what school I attend with pride, and emphasis. With that being said, the "stigma" of attending a school with the word "college" in its name is real, and has little

to no chance of going away. Community Colleges have been around since 1901, with the majority of them dropping the community part, the word college has now been given the 2 year mark. A junior university if you will, which is amazing because it expanded and provided access to a little bit of higher education to those who need it. I didn't appreciate NSA Chair Stanfill making remarks about Nevada State students' mission to end that stigma. As a person of color, having the title university is crucial for me, as I mentioned during my previous public comment my skin color is my biggest barrier when it comes time to apply for jobs. Ending the stigma isn't the issue. There is no stigma actually. The issue is I don't want to be passed up for a job because my employer is assuming I hold an associate degree. NSA Chair Stanfill doesn't have this problem. For one, she is not a person of color, and her school has the word university in its name, so her education won't ever be questioned, jobs will fall in her lap, and that is not her fault, that is just the country we lived in unfortunately. At the end of the day, NSA Chair Stanfill made those remarks not knowing what the true meaning behind Nevada State's name change. We are an HSI institution, we are serving the new majority, and this name change is a way for our students to get opportunities that NSA Chair Stanfill will already does. Thank you for your time today."
