4. DISCUSSION WITH BOARD OF REGENTS CHAIR INFORMATION ONLY

Board of Regents Chair Byron Brooks will meet with NSA members to share his priorities as Chair of the Board of Regents including aspirations and concerns for the higher education system.

Chair Stanfill pulled the item from agenda as Chair Brooks was unable to attend the meeting.

5. DISCUSSION WITH THE CHANCELLOR

NSA members will meet with Acting Chancellor Dale Erquiaga. They will learn of the Chancellor's priorities and share updates from their respective institutions.

Chancellor Erquiaga provided the following updates:

The committee for the ad hoc Chancellor Search met last Friday. The process is underway for the committee and advisory members to build the position profile, timeline, and scope of the search. The legislative session is underway, and the Governor's recommended budget looks very good for NSHE. Some of the Capital projects did not get approved but most of the operating budget items were approved. Upcoming dates for NSHE groups at the legislature were mentioned.

Questions:

Dionne Stanfill asked what the priorities are for the session.

Chancellor: The NSHE priority is to hold what is the recommended budget (from an operations standpoint). Individual institutions will make their cases for their buildings/capital improvement projects.

Kevin Leon-Martinez asked if the Regents have a position on AB81, regarding open carry of guns on campus.

Chancellor: The Regents have not discussed that bill, which fall outside of the existing policy framework; existing NSHE policies will be followed.

Matthew Hawn asked about carrying out a study for NSHE as a whole and what the role of the Chancellor and the Regents would be in that study?

Chancellor: The Governor has put money in the budget for a funding formula study, as well as a management and operations study. Currently, the funding formula rewards weighted student credit hours, with certain degrees and disciplines being compensated at a higher level; it is a 'look-back' formula. It will be reviewed to determine what is working and what is not. On the operations and management side, self-supporting budgets, transparency, and other issues will also be reviewed. We will participate in the conversations and help craft the language as best we can.

Nicole Thomas asked if we will we be receiving a general list of bills that NSHE is supporting and is not supporting.

Chancellor: A list will be provided; Alejandro Rodriguez will explain how that works and how we will share information with constituency groups.

6. DISCUSSION WITH NSHE DIRECTOR OF GOVERNMENT RELATIONS

NSA members will meet with NSHE Director of Government Relations Alejandro Rodriquez. They will learn about the Director's role, information of the 82nd Session of the Nevada Legislature, and ways in which the System and NSA may engage in the legislative process.

Chair Stanfill introduced Alejandro Rodriquez.

Director Rodriguez introduced himself and discussed how he coordinates with each institution as one voice and one NSHE. Each institution will also advocate for their individual priorities. He will be tracking bills that touch on higher education and testifying according to NSHE policy or notify the Board of Regents if bills are outside of policy. Student voice is very important; the legislators want to hear from students and be made aware of their concerns. NELIS is a personal legislative tracker that students can sign up for; it helps track certain bills. There are opportunities for students to testify or submit written comments.

Question: Is the "State of the System" a traditional address (similar to the "State of the State") and will students be invited to attend it?

Rodriguez: It consists of presentations done by the two policy committees in the early part of the session (before hearing some bills). They will ask for the priorities, services that NSHE is providing, and touch on the NSHE strategic plan. It will be a hearing consisting of a 20-minute presentation followed by legislator questions. Because NSHE cannot present its own bills, this provides an opportunity for legislators to learn about NSHE policy and its strategic plan.

Question: Are legislators critical of the leadership turnover in NSHE?

Rodriquez: In the last session, SJR 7, which would remove the constitutional authority for NSHE, was discussed. It is coming back and NSHE is opposed to it, as well as a bill to reduce the number of Regents and their term limits. There are new legislators, and we are taking the opportunity to have a fresh start and educate them.

Question: Can NSHE not propose its own bills?

Rodriguez: That is correct; each legislator has a certain number of BDR's to submit. Certain agencies have certain number of BDR's but not NSHE.

Question: Is there a deadline for submitting BDR's?

Rodriguez: Yes, the deadlines are in NELIS.

7. ELECTION OF NSA VICE CHAIR

FOR POSSIBLE ACTION

NSA will conduct an election to fill the vacant position of Vice Chair. NSHE Senior Analyst Terina Caserto will provide a summary of the process for electing an NSA Vice Chair, and NSA Chair Dionne Stanfill will facilitate the election process. NSA members or any person serving as a proxy for a member may make nominations.

Senior Analyst Caserto explained that the former Vice Chair resigned from the position and the newly elected Vice Chair will hold term through the end of this NSA year.

Secretary Machado self-nominated, then withdrew her self-nomination after clarification of the rules from Lynda King, NSHE Associate General Counsel.

Matthew Hawn nominated Susanna Stankute, who did not accept the nomination.

Chanikan Buntha and Tessa Espinosa self-nominated. Each candidate discussed their qualifications and took questions. Chair Stanfill opened the vote for deliberation. A roll call vote was taken, with seven votes for Buntha and two votes for Espinosa. Chanikan Buntha was elected as Vice Chair.

8. UPDATE REGARDING THE APPROVED NSA <u>INFORMATION ONLY</u> RESOLUTION IN SUPPORT OF AMENDING THE BOARD OF REGENTS *HANDBOOK* TO ALLOW THE NEVADA STUDENT ALLIANCE CHAIR ACCESS TO THE AGENDA

Chair Stanfill will update NSA members on developments following passage of the NSA approved Resolution in Support of Amending the Board of Regents *Handbook* to Allow the Nevada Student Alliance Chair Access to the Board's Agenda, including a debrief with respect to feedback that transpired from the December 1-2, 2022, Board of Regents' meeting agenda item on this topic.

Chair Stanfill updated the members on discussions.

Kevin Leon-Martinez and Yvette Machado may be drafting resolutions at their respective institutions and provide supporting data.

Suzanna Stankute has met with a newly elected Regent Brown, who is supportive; she would like to move forward.

Chair Stanfill noted that passing resolutions in respective governments and performing outreach with constituencies would be helpful with moving this legislative priority forward.

Tessa Espinosa asked what kind of preparation ASUN did beforehand and what evidence led to the conclusions. It would be helpful to have more statistics and research prepared in advance to answer the Regents' questions.

Chair Stanfill noted that much research and outreach was done at UNR, which contributed to the NSA passing its resolution. In the future, it would be helpful to present more tangible research and concrete data with the request to the Board of Regents.

9. MEMBER UPDATES

Each member provided updates from their respective institutions.
