## 3. DISCUSSION WITH BOARD MEMBERS AND CHANCELLOR

#### **INFORMATION ONLY**

Student representatives will have the opportunity to have an open dialogue with the officers of the Board of Regents and the Chancellor. The discussion will include student experiences, concerns of their constituents, and other matters related to their roles in student government.

Chair Stanfill opens the discussion by welcoming the Acting Chancellor of NSHE and the Chair and Vice Chair of the Board of Regents and opening the floor to NSA members to ask questions.

Question is directed to the Chair and Vice Chair of the Board of Regents regarding their opinion to the renaming of Nevada State College to be discussed at the Board of Regents meeting later that same day. Chair Brooks comments he cannot speak on behalf of the Board but does discuss that there will be numerous questions today before determining the direction of the vote from the Board. That the research has been conducted and it there has been transparency.

The Chair and Vice Chair of Regents were then asked about the highlights and lowlights of their new roles. Vice Chair Arrascada spoke of transparency and success. Chair Brooks spoke about the time commitment as a Regent to be effective in areas to make a difference and spoke about opportunities through the challenges presented.

Chair Brooks views the NSA as having a voice, level of empowerment and level of collaboration and continues comments regarding the process of communication with NSA as being important. Chair Brooks speaks of how students can approach the Regents and use the Regents as a resource.

Acting Chancellor Erquiaga gives a general legislative update including budget hearing; a few bill to watch that increase student access through fee waivers and residency requirements. There are also bills concerning nursing, mental and behavioral health.

The Chair and Vice Chair of the Board were then asked about their goals. The responses included being interested in tasks that produce student success such as, but not limited to, dual enrollment program and College and Career Readiness.

Next the Chair and Vice Chair of the Board were asked how NSHE is preparing for students facing homelessness and food insecurity. In general services at the individual campuses were mentioned for providing both resources for homelessness and food insecurities.
