# 4. DISCUSSION WITH NSHE REGENT SUSAN BRAGER <u>INFORMATION ONLY</u>

Regent Susan Brager will meet with NSA members to share her experience and the projects she is currently working on as a Regent. Regent Brager chairs both the Committee to Review the Policies Governing a Search for Chancellor and the Chancellor Search Committee. She will discuss her role within those committees as well as her experience on the Board this last year.

Discussion occurred with NSHE Regent Susan Brager within NSA members. She shared her leadership experience with the State. Brager shared information on the Board Committees she is chairing and then answered a question from an NSA member concerning what she feels is the biggest issue with the k-12 pipeline. Brager then spoke of the desire to see the student go where they want to go for their higher education and that it is not about numbers.

# NSHE Task Force on Power-Based Violence at Institutions of Higher Education <u>Meeting: 12/27/23</u> REPORT

Context

- Assembly Bill 245 created this Task Force
  - Renamed the Sexual Misconduct Task Force
- Based on students' requests and calls to action for the system

Scope of the Task Force

• Expanded from the previous task force to address power-based violence at NSHE Institutions

Duties of the Task Force

- Developing and administrating a climate survey on power-based violence within NSHE institutions
- Review the results of any power-based violence climate survey administered within any institution within NSHE
- Examine current procedures and protocols for preventing, intervening in, or responding to incidents of power-based violence within NSHE
- Identify possible gaps in services that are available for victims of Power-Based Violence within the system
- Examine the correlation between social groups, campus life, and incidents of power-based violence within the institution's campuses
- Provide recommendations to the Board of Regents on how to address power-based violence within NSHE
- Submit to the Joint Interim Standing Committee on Education a written report summarizing the findings of the task force no later than August 1st of each odd-numbered year; furthermore, provide the data collected from responses to any climate survey, and recommendations in regards to the prevention, intervention in, or response to incidents of power-based violence within NSHE
- Task Force must meet once each quarter

# Climate Survey Update

- In February of 2022, the task force heard presentations from UNLV, CSN, GBC, TMCC, RN, WNC, and Nevada State
  - Also heard an overview of best practices and possible survey instruments across the nation and the system
- In April of 2022, the task force heard from Dr. Dahar and all of UNR regarding best practices for climate survey instruments and biennial distributions in higher education
- Possible Directions that were taken into consideration
  - Identifying the extent of the problem (chosen)
  - Climate goals of sexual misconduct
  - Identifying Elements for climate intervention, student's attitudes and behaviors
  - Changes needed for better social conditions
  - Consider the data that practitioners at the institutions needed
- Built on already established climate surveys within our systems and best practices from national surveys
- The basis of the survey would center on dating violence, domestic violence, gender-based violence, gender identity or expression violence, sexual assault, sexual harassment, stalking, indecent exposure
- In March of 2023, the survey was presented to the task force and then recommended to the Board of Regents in June of 2023
  - The survey would reflect AB 245
- New Updates of the Survey
  - Gathering institution-specific data regarding the prevalence of gender harassment and discrimination
  - Estimated number of incidents that are being collected
  - When and Where the alleged incident occurred
  - Extensive information on Students' perception
    - If the incident was reported
    - How the campus responded
  - Information on Leadership of and outside the Institution
  - Perception of awareness about how to refer or report

- Students' Perception and attitudes towards power-based violence and their own experiences, friends, or others they observed
- Awareness of the reporting system and responsiveness of the Institutions
- The survey is not required
- Terminology was explained (power-based violence, sexual misconduct, sexual assault)

# Survey's response TO DATE:

- 5,200 responses, 5,053 students gave their consent on the survey, 147 did not (results will be omitted)
  - CSN: 820
  - GBC: 91
  - NSU: 88
  - TMCC: 184
  - UNLV: 2,829
  - UNR: 902
  - WNC: 49
  - Unanswered in whole or part: 237
