As a worried parent my first reaction is to leap out and find my children which would have put us all in harms way if the alert system didn't allow us to know what was going on. It was also great because as the oldest of the millennials, I never learned duck and cover, hide, turn off lights and all these different things and having an alert system for all these things is helpful for others that may not be aware what is going on. I hate to be pessimistic but there is probably going to be another school shooting. Last year alone there were 656 mass shootings. That is a lot and that sucks. It would be foolish not let that information be elevated in this discussion. And because of that I am heavily in favor of the resolution that the NSA is trying to pass for reasons that should be obvious to everyone here. It is abs necessary to support safety and gun violence prevention and there is no good reason to not support it as the safety of faculty and students should be prioritized over everything else. Every second counts when someone wants to mow down a bunch of people with a gun and faster emergency response times are critical in preventing deaths. I hate to imagine what it would have been like if emergency responders didn't show up as quickly as they did. I also want to say thank you to you guys for trying to get this passed. I am going to UNLV next semester and just moved here from Arizona and I am super excited to start class but less excited now with everything that is going on recently with all these shootings. And the fact that there are other campuses that are not as safe because of the emergency response times is very scary. Thank you for your time. And I very much support your thing.

5. UNR GRADUATE STUDENT CLIMATE SURVEY PRELIMINARY RESULTS

Good morning, my name is Christian Solomon-Lomu for the record, and I'm the State Director for Rise Nevada. I am here to speak in favor of this resolution supporting safety and gun violence prevention on campus. While It really is unfortunate that we have to gather here to present solutions on adapting and surviving with the high frequency of mass shootings in this country, I want to acknowledge how proud I am that student leaders are lighting a beacon of hope for all of us with this resolution.

On December 6th, Rise Nevada had 80 students, staff, and volunteers in the Student Union conference rooms to learn about the intricacies of political organizing and issue advocacy as part of our Rise U training program. The emergency response system first informed my students and a truly diligent UNLV event services staff member named Taylor kept me posted through texting quick and concise updates from the first student emergency notification to police evacuation. It was because of the strength of communication that I could keep my students as calm and prepared as possible while establishing a plan with my team.

To think that other campuses are at risk with a lack of that kind of infrastructure is concerning and this resolution will aim to quell any immediate worries when it comes to the safety of students, faculty, and support staff.

I also applaud the piece within the resolution that focuses on mental health resources. The fact that my team and I were able to see crisis counselors and had recurring support groups to include LVMPD and other non-profits in the immediate aftermath helped immensely in creating a pipeline that could support the mental health needs of survivors who've been impacted by mass shootings.

Good Morning,



A RESOLUTION SUPPORTING SAFETY AND THE PREVENTION OF GUN VIOLENCE ON COLLEGE CAMPUSES

DATE HERE

WHEREAS, the Nevada Student Alliance acknowledges the profound impact of gun violence on college campuses and recognizes the tragic incident at the University of Nevada, Las Vegas, on December 6, 2023, which claimed the lives of three esteemed faculty members: Dr. Patricia Navarro-Velez, Dr. Jerry Chang, and Dr. Naoko Takemaru, wounded three other individuals of those being one professor and two first responders, and left multiple students, faculty and staff suffering from panic attacks; and

WHEREAS, the victims of the UNLV shooting on December 6, 2023, were three faculty members of the university, identified as Dr. Patricia Navarro-Velez, a distinguished assistant professor of accounting; Dr. Jerry Chang, a respected professor of management and information systems; and Dr. Naoko Takemaru a dedicated associate professor of Japanese studies, all of whom were esteemed educators contributing significantly to the academic community; and

WHEREAS, it is deeply regrettable to note that each of the identified professors was a member of minority communities, further underscoring the impact gun violence has on marginalized communities; and

WHEREAS, every student has the right to pursue their education in a safe and secure environment, free from the threat of gun violence; and.

WHEREAS, commendation is warranted for the University Police - Southern Command Officers and first responders for their swift and urgent response time, arriving at the UNLV campus within seventy-eight seconds, undoubtedly preserving the safety of numerous students, faculty, and staff.

WHEREAS, the December 6, 2023, tragedy at the University of Nevada, Las Vegas, underscores the need for proactive measures to prevent future occurrences and protect the wellbeing of students, faculty, and staff; and

WHEREAS, the Nevada Student Alliance is committed to advocating for the safety and wellbeing of all students within the state of Nevada;

NOW, THEREFORE, BE IT RESOLVED BY THE NEVADA STUDENT ALLIANCE:

- 1. The Nevada Student Alliance strongly condemns gun violence on college campuses and calls for immediate and effective action to preserve the safety of students across the Nevada System of Higher Education.
- 2. The Nevada Student Alliance recognizes the various mental health and intervention services available to students, faculty, and staff at each NSHE institution, and encourages students to utilize these resources, while also calling for the allocation of resources to enhance campus security measures, including but not limited to, improved emergency response systems, the implementation of advanced security technologies, and encouraging collaboration between educational institutions, mental health professionals, and law enforcement agencies to address the mental health aspects contributing to gun violence and to provide adequate support.
- 3. The Nevada Student Alliance shall send this resolution to each member of the Nevada federal delegation in Congress, each member of the Nevada State Legislature, each member of the Board of Regents, each member of the Council of Presidents, the Governor, and the Chancellor to prioritize the issue of gun violence and safety on college campuses.
- 4. The Nevada Student Alliance encourages collaboration across NSHE with relevant stakeholders, including but not limited to DEI organizations, University Police Department, and the Chancellor's Ad Hoc Public Safety Committee.
- 5. The Nevada Student Alliance acknowledges and supports the work of the Chancellor's Ad Hoc Public Safety Committee and encourages the Chancellor to consider transitioning it to become a standing committee in the Nevada System of Higher Education.






GSA Student Climate Survey Results 2023-2024 Student Advocacy Committee


Are you a domestic or an international student? (N = 260)



Choose one or more races that you consider yourself to be (N = 278)




What is your current gender identity? (N = 257)


Are you the sole earner in your household? (N = 258)






Are you currently a UNR student and a parent at the same time?


Would you be willing to work on a project that lasted 1-month but would involve an Academic and Industry collaboration? (N = 229)
