1. ROLL CALL

2. PUBLIC COMMENT

Comments will be limited to two minutes per person. Persons making comment will be asked to begin by stating their name for the record and to spell their last name. The NSA Chair may elect to allow additional public comment on a specific agenda item when that agenda item is being considered.

In accordance with Attorney General Opinion No. 00-047 (April 27, 2001), as restated in the Attorney General's Open Meeting Law Manual, the NSA Chair may prohibit comment if the content of that comment is a topic that is not relevant to, or within the authority of, the NSA, or if the content is willfully disruptive of the meeting by being irrelevant, repetitious, slanderous, offensive, inflammatory, irrational or amounting to personal attacks or interfering with the rights of other speakers.

3. DISCUSSION WITH BOARD MEMBERS AND NSHE CHANCELLOR

NSA members will have the opportunity to have an open dialogue with the officers of the Board of Regents and the Chancellor. The discussion will include student experiences, concerns of their constituents, and other matters related to their roles in student government.

Chair Stankute opened up for NSA members to ask questions of the Chancellor and Board officers.

Regent Carvalho answers a question regarding her goals during her term as Chair of the Board. Carvalho states she would like better communication, getting the Board in one direction and one vision. Regent Downs adds he is looking for cohesion on the Board and goals common to everyone. Specifically he wants

the co-requisite policy to allow for boot camps for math and English; work on the Peoplsoft system to be able to transfer credit around; and a common application.

The Chancellor answered a question about how graduate students at Nevada State, who do not have a student association, can be heard in shared governance. Board has policy and procedures for students to establish a student association. Chancellor reminds NSA Members that they have full access to her at any time and student voice is important. Regent Carvalho provides additional comment that student voice was important when provided for the recent conversations around COLA.

Chancellor addresses an additional question regarding having a standing safety committee. She wants policy to come forward regarding structure to be sustained. Working with the legislature may help and financial support is needed.

Chancellor addresses a question regarding how the student body presidents can work with the System during the upcoming 2025 legislative session. Chancellor introduces Alejandro Rodriquez who is sitting with the public during the meeting. Alejandro comments about starting early in the legislative session and working together.

Regent Carvalho responds to a question regarding how the Board will work with the professional schools and how the Board will include the professional schools in the strategic plan. She comments about the Health Sciences committee and has entertained the thought of having a committee that focuses specifically on the professional schools. The Chancellor adds that medical is a priority for the state of Nevada.

Regent Downs addresses a question regarding the recent legislation placing a reduction in the number of Regents and their terms by stating that it was passed in the legislature without any specific plan. Regent Carvalho addresses that Ballot Question 1, if passed, will take the Regents out of the Nevada Constitution and there is no plan yet for how that would look yet. Regent Downs expresses that he would prefer an elected board, not appointed.

Regent Downs answers a question about the future of dual enrollment by expressing we must be careful to not enroll students who are not ready as it could hurt students. Regent Carvalho expresses that it is important to give underrepresented students the opportunity to enroll while in high school. She also comments that a discussion regarding mission differentiation and affordability with the institutions must be had and strengthening the partnership with K-12. The Chancellor then comments that we need consistency with institutions, compliance with accreditation and those discussions are being had with the Academic Affairs group and Presidents.

Working with them over the last three years we have been heard, whether the Board has been supportive or not, but that is part of the legislative process. I want to thank you for listening. Thank you to Terina for being an incredible mentor and keeping NSA cohesive year after year.
