# 4. CIVIC ENGAGEMENT LETTER TO BOARD AND NSHE PRESIDENTS

## **FOR POSSIBLE ACTION**

The letter may be shared during the NSA Chair's Report to the Board of Regents later that day, as well as forwarded to each NSHE President. The NSA will discuss the proposed letter and may suggest revisions or modifications. The letter may be approved at this meeting or returned at a subsequent meeting for formal action by the NSA. Chair Osorio-Hernandez discusses the letter in the attachment sent via email will be addressed.

The goal for Kevin's NSA time is the students' commitment to civic engagement.

The letter was discussed as not a performative act but as committed to students' commitment. In addition, the letter should allow students to be part election workers vs. saying sharing a report, president's office or someone in leadership or the Student Body Presidents to work closely with the president.

Chair Kevin read the letter.

Edits or suggestions to the letter.

Teresa Marie – CLD committee for UNLV, stated that it's good to expand to other schools to get involved.

Allister Diaz—Having a collective in democracy is important; having students get democratically engaged in their campus and community is important, and this is something that impacts students. Janeth Vences-Balvas – CSN is a dual enrolled school and having high schools involved would allow for them to partake in a job due to working as election workers.

Chair Osorio-Hernandez – asked how to proceed with the motion and what needs to be added as an amendment

Teresa Marie – suggested amendments.

Carie Parker: The involvement of the presidents and how the student body presidents will work with the president's office.

Teresa Marie—There is a civil engagement committee on campus; the learning and leadership department works independently. Allister is also part of the committee. Adding the president to get involved may result in more hands in a pot that may become more confusing.

Chair Osorio-Hernandez- Asked how collaboration with presidents would work?

Teresa Marie – Getting the presidents involved and including on-campus events specifically for voter registration; she doesn't want to cause any backup in the process.

Chair Osorio-Hernandez – Asked about how the backup process would occur.

Teresa Marie- explained how the process works at UNLV.

Kevin- Is there any process at UNLV for the current presidents?

Terina Caserto: Activities will fall under the VP of Student Affairs to advise of the activities on campus.

Teresa Marie—Instead of having the language to the President, include language to higher education leadership.

Carie Parker: – Changing the terminology of the letter; each student body will report back to the NSA with what was most effective at the institution; 'This will allow us to co-create best practices.

Lisha Allison – Voter engagement at her campus goes through her advisor and does not involve other parties on her campus.

#### Motion:

Kevin asked to change the 5<sup>th</sup> bullet point to encourage students to volunteer or work as election workers.

Edit language within the second to the last paragraph as: Each student government body president will be reporting back to the Nevada Student Alliance post-election pertaining to the civic engagement initiatives that have been most effective at your institution. This will help us all co-create best practices as we continue to work together to make civic engagement a cornerstone of our campus communities.

Teresa Marie—Started the initiative with Athletics to build a graduate community on campus. Other partners have begun working with them, and there will be tabling with them and working on a night at the symphony for non-traditional students. Students can bring family and friends to the event, which will expand and build a sense of community 18-Sept, football game against Fresno in September.

Lisha Allison: Sept 17<sup>th</sup>; whole day event for spirit day with lots of student interaction and foster culture on campus. On October 1<sup>st</sup> pastries with the presidents happening and there will be free food. That same day they will have a blood drive and national coming out date on 10-Oct. with free food and an event on campus.

Janeth Vences-Balvas: Reported on CSN club rush events actively occurring and welcome back events happening at all 3 main campuses in the next few weeks. Voter Registration push will be done in Sept. and Oct. Pizza with the Presidents event is in the works for late Sept.

Chair Osorio-Hernandez: 3 weeks of welcome week events last week. There have a senate of 23 members, and currently at 16 members. They will be working on a service project, PB&J and will be working on feeding the homeless of the tunnels in Las Vegas.
