Chair Trevor Hayes called the meeting to order at 8:30 a.m. with all Regents' Committee members present.

1. <u>Information Only-Public Comment</u> – Chief of Staff and Special Counsel to the Board Dean J. Gould entered into the record public comment submitted by the following individuals in support of Dr. Chris L. Heavey as the next president of the University of Nevada, Las Vegas (UNLV): Mr. Nathaniel Waugh, Ms. Heather Torgersen, Mr. Jessica Impallaria, Mr. Patrick Alejaga, Mr. Alex Culley and Mr. Gregory Morris.

Chief of Staff and Special Counsel Gould also entered into the record public comment submitted by Ms. Nicole Thomas expressing concerns regarding the virtual public comment deadline of Tuesday, July 21, 2020, at 4:00 p.m., and the final candidate feedback forms provided to faculty and students during the forums. She also shared her strong support for either Dr. Chris L. Heavey or Dr. Keith E. Whitfield as the next president of UNLV.

Chair Hayes spoke of the late Regent Sam Lieberman's love for UNLV, and his passion for higher education and the community. He requested a moment of silence in honor of Regent Lieberman.

2. <u>Approved-Minutes</u> – The Committee recommended approval of the September 27, 2019, meeting minutes (*Ref. UNLV PSC-2 on file in the Board Office*).

Regent Carvalho moved approval of the minutes from the September 27, 2019, meeting. Regent Perkins seconded. Upon a roll call vote, the motion carried unanimously. Chair Hayes, Regent Carvalho, Regent McAdoo, Regent Perkins and Regent Trachok voted yes.

- 3. <u>Information Only-Chancellor's Report</u> Chancellor Thom Reilly reported on the search and interview process and announced the names of the final candidates:

 - Keith E. Whitfield, Ph.D. (Ref. UNLV PSC-3d on file in the Board Office)

Chancellor Reilly commented that the candidate pool from which the finalists were selected was very extensive and robust. He believed any four of the finalists would do an outstanding job as the next UNLV President.

- 4. <u>Information Only-Chair's Report</u> Chair Hayes provided a brief overview of the candidate forums; the interview process; comments regarding UNLV's growth over the years and the importance of its role in Nevada's history; and shared his gratitude and appreciation of the UNLV community for the thoughtful and thorough input in respect to each of the finalists.
- 5. <u>Information Only-Discussion of Interview Questions</u> Chair Hayes and the search consultants led a discussion with the Committee related to the questions and topics to be covered during the interviews. The same questions will be asked of each candidate.

The report included input received from the forums and the results from the surveys received from each final candidate's campus forums. The search consultants reviewed the curriculum vitae and background information of each final candidate just prior to each final candidate's interview. The Committee interviewed the final candidates for the position of the UNLY President.

8. <u>Approved-Decision by the Regent's ad hoc UNLV President Search Committee</u> – The Regents' ad hoc UNLV President Search Committee discussed and assessed the final candidates for the position of UNLV President. The Committee recommend Dr. Keith E. Whitfield for appointment as the next president of UNLV for consideration by the full Board of Regents at its July 23, 2020, special meeting.

Chair Hayes thanked Wheless Search and Consulting, Chancellor Reilly, Board staff and UNLV staff for their work on the search. He welcomed input from

Board Chair Doubrava said his top two choices are Dr. Heavey and Dr. Whitfield with no differentiation between first and second. Regent Carter ranked Dr. Furton as his first choice and Dr. Whitfield as his second choice. Regent Levine selected Dr. Whitfield as her first choice.

Chair Hayes asked the Regents' Committee members to share their assessment of the candidates.

Regent McAdoo selected Dr. Whitfield as her first choice.

Regent Trachok selected Dr. Whitfield as his first choice.

Regent Perkins ranked Dr. Whitfield as her first choice and Dr. Heavey as her second choice.

Regent Carvalho ranked Dr. Heavey as her first choice and Dr. Whitfield as her second choice.

Chair Hayes ranked Dr. Furton as his first choice and Dr. Whitfield as his second choice.

Whitfield for appointment as the next president of UNLV for consideration by the full Board of Regents at its special meeting on July 23, 2020. Regent Perkins seconded.
