Chair Brooks called the meeting to order at 8:30 a.m. with all members present except Regents Cruz-Crawford and Perkins. Regent Brager led the Pledge of Allegiance.

- 2. Information Only 2023-25 Biennial Budget Briefing Acting Chancellor Dale A.R. Erquiaga and Chief Financial Officer Andrew Clinger provided an update on the status of the 2023-25 Biennial Budget Request, including the Cost of Living Adjustment (COLA) being considered during the 2023 Session of the Nevada State Legislature. In addition, each President presented the budgetary impacts of the proposed COLA and how their respective institution would implement the COLA if it were ultimately adopted. 2. <u>Information Only – 2023-25 Biennial Budget Briefing</u> – (Continued)

Regent Cruz-Crawford entered the meeting.

Regent Goodman stated in 2019 the Legislature made an error that it did not correct. Now, NSHE is the only agency receiving COLA funding at 65 percent rather than the 80 percent that the other agencies are receiving. It is frustrating to discuss raising fees and implementing furloughs because of the Legislature's error.

In response to a question from Regent Carvalho related to differences between the reference material and the *Procedures and Guidelines Manual*, Chief Financial Officer Clinger responded that the numbers do not match because in the reference material he is only using the portion of the student fee that goes to the State Operating Budget.

Regent Del Carlo agreed with the Public Comment that NSHE would gain and lose simultaneously. The conversation is unsettling because the Legislature created this, which has not been fixed.

Regent Brager stated providing a united front will make a difference. Education is essential and needs to be adequately funded to show Nevada is a state that values education. Regent Brager added that placing this burden on the students is not correct.

Regent Boylan believed NSHE would be in trouble if it did not start tightening its belts. There must be an employment freeze instead of burdening the students.

Regent Perkins entered the meeting.

Each President presented the budgetary impacts of the proposed COLA and how their respective institution would implement the COLA if it were ultimately adopted.

Regent Downs stated he appreciates Governor Joe Lombardo and the Nevada Legislature for funding NSHE and the COLAs. He asked the Legislature to restore the funding as proposed by the Governor. Regardless of how the money is supplied, NSHE must fund this COLA. He has heard theories about distrust between the Legislature and NSHE, and it would be nice to find time to resolve those issues. His understanding, and he is not sure it is correct, is that this started when NSHE asked to keep its student fees rather than send them to the General Fund and have the Legislature return them to NSHE. He asked those with institutional knowledge if he was correct.

Regent Downs stated he is frustrated with the methodology of how institutions are funded. A funding formula was developed during a past session that changed how schools were funded by removing the rural factor and creating a structure through which four-year schools could get progressively compensated by offering higher-level classes. Schools like Western Nevada College and Nevada State College adjusted their course offerings and delivery methods to comply with the priorities set by the Legislature in the funding formula.

The Legislature has effectively ignored the formula by reducing the Governor's proposed funding to smaller schools while larger schools receive over the Governor's recommendation. Regent Downs added that he would not advocate for any institution receiving less. Still, smaller schools do not deserve to be penalized for adhering to the formula priorities established by the Legislature.

Finally, Regent Downs suggested that at future legislative sessions, NSHE use one set of lobbyists that put forth the interests of the System to avoid the impression of individualism and show unity and a common NSHE purpose.

Regent Perkins left the meeting.

In response to Regent Downs' comments, Acting Chancellor Erquiaga stated the formula revision in 2013 is when NSHE's ability to keep its fees occurred. The COLA shift from 80 to 65 percent occurred only four years ago. Acting Chancellor Erquiaga added there will be a Bill tomorrow morning to discuss the revision of the funding formula, which he believes will address institutional disparity and the cost of higher education. He echoed the comments to work with the Legislature in the interim to discuss the vision and future of the state.

Acting Chancellor Erquiaga noted that Nevada State College lost a peer employee member in the President's Office, and he appreciated NSC President Pollard's attendance today.

Chair Brooks stated that everyone must work together to support the COLA increases. NSHE is thankful that the Governor has made the amendment. NSHE is optimistic that the legislative bodies, through the voices of the institutions, System Office, and the Regents, will clearly see that the \$26 million gap has to be supported; otherwise, there will be unintentional consequences that will reduce the quality and effectiveness of things that have to be done at the institutions. He implored the Presidents and staff to do what they can to help the Legislators understand that NSHE needs this funding and it will significantly affect higher education in Nevada if the gap cannot be closed.

Regent Goodman was unaware of issues with the Legislature, and she has been wellreceived anytime she has been there. She will reach out to ensure they know the students will suffer because of this disparity.

4. <u>Information Only – Public Comment</u>

Jim New provided in-person public comment that the Nevada Faculty Alliance will oppose furloughs. Due to the predictable pricing model, fee increases are based on experienced inflation but will go into effect five years from now.
