
UCCSN Board of Regents' Meeting Minutes October 12-13, 1903

It was ordered that the funds of the Agricultural & Mechanical

College be divided with the Farmers and Merchants Bank from and
after January 1, 1904 and that a bond be given to the Treasurer

for said funds.

The recommendation of President Stubbs in his report relating to a building for a Dining Hall was laid over for further consideration.

A leave of absence was granted to Miss Anna H. Martin from January 1 to September 1, 1904. Also to extend the time to September 1, 1905 if so desired without salary.

Dr. Stubbs requested that he place his house on the Station Farm which was granted.

A requisition for \$800 for the purchase of stock for the Experiment Station Farm was granted to Professor True.

On motion, Professor True was authorized to purchase a cream separator at a cost of \$100.

Mr. Richard Brown was instructed to have border and papering done in the Reception Room of the Girls' College.

The President of the Board was authorized to fit up a blue print room and additional drafting room for Professor Blessing.

On motion, a requisition was granted to Professor Blessing for tools in the Shop.

The bid of F. W. Braun & Co. for equipment for the Department of Physics was accepted.
