O. B. cars, Reno, Nevada @\$8.50 per ton. On the grounds at the University, @\$9.00 per ton. The coal will be of best character and shipped in box cars. Terms cash.

The bid of E. L. Drappo for wood and coal being the lowest and best, on motion of Regent Booher, seconded by Regent Starrett, the contract was awarded to Mr. Drappo.

Upon motion duly seconded and carried, the Board was authorized to file a complaint with the Mayor and City Council requesting that body to revoke the license of the Oberon Saloon and Gambling House, a copy of which is as follows:

September 30, 1905

To the Honorable Mayor and City Council of the City of Reno

Dear Sirs:

We, the undersigned, Regents of the Nevada State University, in compliance with a resolution duly passed at a meeting of said Regents, held on the 30th day of September, 1905, hereby make complaint to your Honorable Body that the so-called Oberon Saloon and Gambling House, conducted by Wacker & Company, situated in the City of Reno, did, on or about the twenty-fifth

day of September, 1905, permit a minor to enter the said Saloon and Gambling House and to loiter and gamble therein.

We request your Honorable body to take appropriate action on this complaint.

A communication was received from the Library Committee with reference to a bequest recently made in favor of the University by Mrs. M. E. Rousseau, which was ordered sealed and filed in the University safe. Report of the Library Committee received and ordered placed on file.

Upon the request of Professor Kennedy and the recommendation of President Stubbs, that piece of land lying east of the road west of the fence, and south of the Orr Water Ditch in the front part of the Campus be assigned for a Botanical Garden, except so much of the ground as may be used for a street when the extension of Lake Street is made, was approved.

Upon motion of Regent Booher, seconded by Regent Starrett, the President of the University was authorized to purchase porch furniture for Manzanita Hall, cost not to exceed Seventy-Five dollars.

On motion of Regent Starrett, seconded by Regent Booher, the Secretary was instructed to review Policy of Insurance on Morrill Hall for \$10,000.00 with Bank of Nevada, expiring October 27, 1905.

On motion of Regent Booher, seconded by Regent Starrett, the Secretary of the Board was instructed to have a new policy of insurance written on equipment in the Mining building and to be given to R. H. Mallett, Agent at Elko, Nevada.
