The Board of Regents met in the Office of the President of the University of Nevada on Wednesday, December 31, 1919, at 11:30 o'clock. There were present Vice Chairman North, Mrs. Hood and Mr. Pratt, President Clark and Comptroller Gorman. Absent: Judges Curler and Cheney.

The meeting was called to order by Vice Chairman North.

Mr. Pratt moved that List No. 16, State Claims Nos. 221 to 231 inclusive, and including No. 215, which was laid over from the previous meeting, for the sum of \$4248.32, and List No. 17, covering Checks Nos. 118 to 123 inclusive, for the sum of \$3376.67, be approved. Vote:

Mr. Pratt moved that, on the recommendation of President Clark, the University should purchase the positive and negative films of the St. Marys-Nevada and Santa Clara-Nevada football games from the Tri-State Motion Picture Company for the sum of \$100, to be paid from the Regents' Contingent Fund, with the understanding that any profit from the use of such films should be applied as follows:

- 1. To care for the handling of the film in covering necessary carriage charges, etc.;
- 2. To reimburse the Regents' Contingent Fund to the

amount of \$100;

3. Any surplus beyond these two items to be turned over to the general fund of the student body.
