Discussion with reference to these two appointments showed clear consensus of opinion of the Regents that each election for a year should be understood to be an election that called for payments for a complete year from the time payments began, always provided that there be no accepted resignation or dismissals specified to occur at a date within the year.

President Clark reported progress on the work turned over to Mr. Gorman and him in the matter of securing vault door, finish hardware, electric light fixtures and some outside wiring for the new Mining Experiment Station building. A door has been secured for \$280, the outside wiring will cost \$675, and the finish hardware \$250. They are about to close with regard to lighting fixtures. The above fixtures indicate a savings in the funds available for these purposes of between \$200 and \$300.
