The Regents met in the Office of President Clark on Tuesday, May 29th, 1923, at 10 o'clock A.M. There were present Regents Pratt, Hood and Talbot, President Clark and Comptroller Gorman.

President Clark recommended that Mr. Lewis E. Rowe be re-elected Instructor in Music at a salary of \$2250 for the year beginning September 1, 1923. Mrs. Hood made the motion. Vote:

President Clark recommended, on the recommendation of Director Doten, that the salary of Professor George Hardman be increased \$120 per year, from \$2700 to \$2850, beginning July 1, 1923, the increase to come from Agricultural Experiment Station funds. President Clark recommended, on the recommendation of Directors Doten and Records, that the salary of Dr. Lyman R. Vawter be increased \$300, \$150 to come from State Veterinary Control funds and \$150 to come from Experiment Station funds, increase to be effective July 1, 1923. Mrs. Hood moved the adoption of the President's recommendation.

Judge Talbot moved that the matter be passed until the next meeting, when a full Board might be present.

President Clark recommended that the student fee be increased, upon the request of the Associated Students, from \$6 per semester to \$6.60 per semester, the extra 60 cents to entitle each student to a semestral paid subscription to the new University Quarter, The Desert Wolf. Mrs. Hood moved the adoption of the President's recommendation. Vote:

President Clark read a portion of a letter from Mr. Elmer L. Shirrell, Chief of the Rehabilitation Division of the Veterans Bureau, with headquarters in San Francisco, quoting parts of a report made to him by the officials in charge of the University of Nevada unit of Veteran Bureau men commending the University for its share of this work of rehabilitation.

Mrs. Hood brought up the matter of drinking in Lincoln Hall. President Clark read a letter from Professor A. E. Turner, in charge of the Hall, reporting conditions at the Hall and elsewhere in the town in respect to the drink evil. General discussion followed.
