The Board of Regents met in the Office of President Clark at 9 o'clock Saturday, June 28th. There were present Chairman Pratt, Mrs. Hood and Judge Talbot. Absent: Mrs. Williams and Mr. Williams.

President Clark read letters from Mr. W. A. Clark, Jr. and from Mr. Clarence H. Mackay re. future building prospects for the University.

On the recommendation of Professor Stanley Palmer, President Clark recommended the election of Mr. Benjamin A. Fisher to be Instructor in Electrical Engineering for the coming University year, at a salary of \$1800 to be paid in 12 equal monthly installments, service to begin August 25th and salary to begin from September 1, 1924. President Clark presented Mr. E. K. Fowler's estimates for the cost of constructing a mezzanine floor in the University Library, the sum total being \$2,081.75. This total estimate includes the cost of materials, labor and also 10% additional as Mr. Fowler's pay.

Judge Talbot moved that the Board approve the estimates and authorize Mr. Fowler to proceed with the construction of this mezzanine floor according to the plans and estimates he has submitted to the Board, the bills to be paid from the Permanent Construction Funds. Vote:

The matter of proper heating of University buildings came up for discussion. President Clark asked to be excused after having outlined the report of the heating engineer who came from San Francisco. Chairman Pratt had the written report of this engineer. After some further general discussion on this important matter, Judge Talbot moved that the Board adjourn until July 15th, 1924, at 9 o'clock, when it was hoped to reach definite decision regarding the heating of Manzanita and Lincoln Halls and to consider the purchase of an additional pump for the Central Heating Plant and a heater for the Training Quarters.
