President Clark read two recent letters from Mr. W. A. Clark, Jr.

President Clark read an invitation from the "Aggies" to the Regents to join the Governor's party in visiting their Agricultural exhibits at 1 o'clock, Friday, October 31st. The invitation was, on motion of Mrs. Williams, unanimously accepted and the Secretary instructed to convey their acceptance and appreciation of the invitation to President Mc Elroy of the Agricultural Club.

President Clark read the invitation from the Artemisia that the Regents should report to the Riverside Studio and have their pictures taken for the 1925 Year Book. This they agreed to do after luncheon.

As a matter of gratification to the Regents, the President read a letter from President Campbell of the University of California in which President Campbell expressed his appreciation of the copy of the history of this University's first 50 years and congratulated Nevada upon the standing won during that period.

After considerable discussion, it was decided that President Clark should prepare for newspaper publication in December a statement of the University's sources of income, which would show clearly the burden on the tax payer for University support and the per capita cost to the State for each student educated at the University.

The question of an increase in Commissioner Dinsmore's salary was discussed and the Board members expressed themselves to the effect that Mr. Dinsmore's salary was probably adequate.

President Clark recommended that the Regents subscribe for:

- 1. 80 copies of the 1925 Artemisia, with a full-page advertisement of the University, at a price of \$300.
- 2. 60 copies of The Desert Wolf at \$1.20 per copy (\$72.00). The Desert Wolf is also to carry a full-page advertisement of the University in each of its quarterly issues.

Some discussion of the matter of certificates of recognition to be presented by the University to farmers elected by a Committee of five for progress along the special lines of their endeavor was had before luncheon. Letters had been submitted from Dr. Records and Directors Creel and Doten expressive of their views on the matter. After luncheon Mrs. Hood moved that the proposi-

tion as outlined in Dean Stewart's letter be adopted, the certificates to be awarded annually during the Farm Bureau convention and that, in accord with the suggestion by the three Division Heads consulted, the certificates be given as from the College of Agriculture of the University of Nevada, rather than as from the University.
