President Clark read the following letter from Dr. Henry Albert and recommended that the University accept this gift and that Mr. Gorman should have the proffered autombile listed as a University car.

The work of the State Hygienic Laboratory requires considerable use of an automobile. I have, during the past 4 years, used my own car and submitted a monthly bill on the mileage basis. It will be more satisfactory from the standpoint of both the Laboratory and the person in charge, if the car is owned by the University. I shall be pleased to present the car which I have been using to the University for the use of the State Hygienic Laboratory. The car is a Chevrolet Touring, Model 490 (1921) Engine No. T49204. This year's license number is 924. The car is in good serviceable condition. It has been driven about 20,300 miles and was, early this year, equipped with 4 new tires and a new battery.

Judge Talbot suggested that a garage might be erected on the Laboratory grounds and the President agreed to look into this possibility.

On the recommendation of the President, Judge Talbot moved that the following plan of Dr. Albert for carrying on the work of the State Hygienic Laboratory during his 10 month's leave of absence from September 1, 1926 to July 1, 1927, should be approved:

- a. Dorothy E. Foster to be Acting Director from September 1, 1926 to July 1, 1927 at a salary of \$175 per month;
- b. Dr. A. L. Grover to be consultant at a salary of \$50 per month for a 1-hour per day service from September 1, 1926 until Dr. Albert's return;
- c. Mrs. Marie Strassburger and Miss Marjorie Roach to be

employed on a month to month basis at \$125 per month as Technicians, their salaries to begin with September 1, 1926;

- d. Stenographic appointment to be left in the hands of Miss Foster with understanding that the rate is 37 1/2 cents per hour;
- e. If there should be large increase in the paid, private work of the Technicians, an extra person at \$125 per month may need to be employed.

Bids for supplying the University's fuel oil for the coming year were opened. The California Petroleum Corporation, Shell Oil Company, Union Oil Company, Standard Oil Company and Associated Oil Company quoted prices. All bids were the same, \$1.89 per bbl., save that of the California Petroleum Corporation, which was 4 cents below the market. After the bids had been read, the two representatives of Reno Oil Agencies withdrew.

Mrs. Catherine Luke appeared to ask the Regents to consider the purchase of 40 acres of land of the Evans Estate, lying to the north of the University Campus and to the east of Virginia Street and west of the Western Pacific tracks, at the price of \$500 per acre. Some of the land lying below the ditch carries with it water rights and may be cultivated. After presenting her cause, Mrs. Luke withdrew.

Judge Talbot stated that originally the Evans holding in the Highland Ditch had been 200 inches. President Clark is to consult with the agent of the heirs, secure a blueprint showing the irrigable and non-irrigable land, to find out what water right the irrigable land carries and whether or not the Evans Estate would offer the land to the University at a price less than \$500 per acre.

President Clark read the following letter from Dr. Albert to Governor Scrugham for the information of the Board of Regents:

Governor James G. Scrugham Carson City, Nevada

Dear Sir:

A few days ago, I discussed with President Clark of the University the budget for the State Hygienic Laboratory for the biennium of 1927-28.

I quote from the budget presented the following relative to the discontinuance of private work by the Laboratory:

The public health portion of the work of the Laboratory has grown to such an extent that it seems advisable to discontinue the performing of work of a private or personal nature, except for consultations on the part of the Director. The increase in work consists not only of an addition to the number of specimens examined, but also of an increase in the type of diseases in which the Laboratory can be of service, and an increase in the complexity of the work due to refinements in laboratory methods.

If private work is eliminated, it will, of course, mean the loss of income from that source. The public health work is, however, of such importance that it seems advisable to limit the work of the Laboratory to such. The private work which needs to be done can be taken care of by the Pathologists of the local hospitals.

President Clark feels that the income for the "service" divisions of the University may not permit the appointment of the staff as recommended and at the same time eliminate the income from private work. I suggested that in view of the epidemiological work which we were doing, the State Board of Health may be willing to contribute the salary for a Technician for the Laboratory -- namely \$1500 per year, or \$3000 for the biennium. President Clark accordingly asked that I present this matter to you and the State Board of Health. I may say that if the organization of the State Board of Health remains as it is at present and it should be decided to employ an Epidemiologist, it would not be possible to secure a competent one for less than about \$3500.

After this decision is reached, the Chairman and President are authorized to pay to Mr. Mosier, the balance due him on his contract less his share for any damage caused by the moving of the building.
