> REGENTS MEETING June 6-7, 1947

The regular meeting of the Board was called to order by Chairman Ross at 2:15 P.M., in the President's office. Present: Regents Henningsen, Sheerin, Hilliard, Cahlan, Ross; Comptroller Gorman and President Moseley.

Motion of Mr. Cahlan passed unanimously that the reading of the minutes of the previous meeting, April 11-12, 1947, be dispensed with and that they be approved as submitted.

Heating Plant - Mr. Holcomb, Chairman, and Mr. Mac Kenzie, member, of the State Planning Board, met with the Regents at their request, to report for the Planning Board on the status of the plans and funds for the new University Heating Plant. The contract with the firm of Headman, Ferguson and Carollo having been completed with the submission and acceptance of plans and specifications, the Planning Board had felt it desirable to have these plans inspected and the local firm of Blanchard, Maher and Lockard was engaged at a cost not to exceed \$1000, which amount is to be paid out of the State appropriation for the Heating Plant. A meeting of Mr. Holcomb and Mr. Mac Kenzie with Mr. Lockard had been scheduled for 3 P.M., this day (June 6, 1947) and Mr. Ross asked that they report back to the Board of Regents.

Geology Department - At 3:15 P.M. Dean Palmer, Dean Wood, Director Carpenter, Professor Gianella, Professor Wheeler and Professor Cree came into the meeting at the invitation of the Regents in order that the members of the Geology Department might have an opportunity to appear before the Regents to determine where the lines of authority meet in regard to the Department of Geology.

Motion of Mr. Cahlan passed unanimously that the Board of Regents reiterate its decision in moving the Department of Geology from the College of Arts and Science to the College of Engineering, and, further direct and rule that the Chairman of the Department

of Geology report only to the Dean of Engineering.

Newlands Experiment Farm, Fallon - A letter was read by President Moseley signed by F. W. Parker, Assistant Chief of Bureau in Charge of Soils and Agricultural Engineering and a reply written by Mr. Fleming, which was submitted for the opinion of the Board of Regents.

Motion of Mr. Cahlan passed unanimously that, with changes noted by the Chairman, Mr. Fleming's letter be approved for transmittal to Mr. Parker, and, further, that the Board believes it has the right to accept the Farm as a gift, and that the Comptroller be instructed to get an opinion from the Attorney General as to whether paragraph 13 of Section 3 of Chapter 229, Statutes of Nevada, 1945, gives the Regents this authority and if so, the Comptroller and the President be authorized to seek the help of our congressional representatives in securing transfer of title to the University of Nevada in the event the Farm is to be liquidated as of July 1, 1947, as per the letter from Mr. Parker.

# South Virginia Farm

Motion of Mrs. Henningsen passed unanimously that the Chairman of the Board be authorized to sign the following:

- 1. Lease of University Farm from July 1, 1947 to October 1, 1947 to Mrs. Washburn at \$900 for 3 months period.
- 2. Memorandum of rental of pasture on the University Farm from May 27, 1947 to October 1, 1947 to Mark E. Eisle at \$350 for the period.

Board of Athletic Control - President Moseley presented a letter from Harry Frost, Chairman of the Board of Athletic Control, requesting that the Board of Regents continue its financial support to the athletic program as in previous years.

Motion of Mr. Sheerin passed unanimously that the sum of \$2400 be applied from the general funds of the University to the salary of the Athletic Director for the academic year, 1947-48, in consideration of services which the Director of Athletics renders to the students in the Department of Physical Education for Men.

New Gymnasium - In line with the request of the Regents on its inspection tour, April 11, 1947, the Comptroller presented for consideration a bid on main court baskets to be hung from the ceiling in the new Gymnasium.

Motion of Mr. Cahlan passed unanimously that the bid in the amount of \$855.40 be accepted and that the Comptroller be authorized to draw a check in that amount plus installation costs.

Dining Hall - Referring to page 65 of the 1946-47 catalogue, item 4 under "Regulations Governing the Univerity Dining Hall".

Motion of Mr. Cahlan passed unanimously that the statement be changed to read as follows:

Rebate for necessary absences or from withdrawals from the Dining Hall will not be made for a period of less than one week. For absences involving one week or more, the rate of rebate will be 4/5 of the amount paid by the student for the period in question. Due notice must be given and permission secured in advance, or no rebate will be allowed.

Comptroller Gorman read a letter from Mr. Allison asking that the University pay part of the expenses for putting in a retaining wall on his property to keep the water from the drainage ditch on the University Farm from flooding the grounds. It was unanimously agreed to leave the matter to the Comptroller for report at a later meeting of the Board.

The Board recessed at 6:30 P.M. and was called to order by the Chairman at 9:30 A.M. Saturday, June 7, 1947.

#### D. Gifts

- The balance in the Special Welfare Fund in the amount of \$2226.04 from the decommissioned U. S. S. Reno has been turned over to the University of Nevada to be set aside for aiding surviving children of men and officers killed in action or who died of wounds received while in action on the U. S. S. Reno.

- 5) Mr. George Johnson of Reno added \$200 to the Scholarship Fund for the 2 Greek women at the University.
- 6) Mr. Peter Demosthenes of Reno added \$200 to the Scholarship Fund for the 2 Greek women at the University.
- Mr. Marty Hess of Sonoma, California, gave \$50 to be used for some needed piece of equipment for the Physics Laboratory.

# Comptroller's Report:

Motion of Mr. Sheerin passed unanimously that the following list of claims as approved by the Executive Committee, be approved:

List No. 11, dated April 30, 1947, covering State Claims 67-143 to 67-158, inclusive, for a total of \$45,807.04.

List No. 12, dated April 30, 1947, covering Regents Checks 67-266 to 67-297, inclusive, for a total of \$148,089.71.

List No. 12, dated May 31, 1947, covering State Claims 67-159 to 67-173, inclusive, for a total of \$40,281.93.

List No. 13, dated May 31, 1947, covering Regents Checks 67-298 to 67-329, inclusive, for a total of \$135,171.84.

University Heights Dormitory Lease - Lease on Dormitory No. 27 expired December 31, 1947 and on Dormitory No. 28 on January 31, 1947.

Motion of Mr. Sheerin passed unanimously that the Comptroller

be authorized to try to get the lease renewed for \$1 per year, and if this cannot be done, that the new lease as presented, be accepted, with the approval of the Attorney General.

Retirement Plan - A letter from Mr. Creel requests that he be permitted to continue in the University Retirement in addition to his participation in the Federal Retirment Plan.

Motion of Mrs. Henningsen passed unanimously that the request be not granted, but that Mr. Creel be advised that he is at liberty to pay the entire premium on the University policy and thus keep it upon on his own.

University Cars - Effort has been made, without success, to secure 3 automobiles from Government surplus property.

Motion of Mr. Sheerin passed unanimously that the 1929 pickup now used by the Superintendent of Maintenance be assigned to the University Carpenter for Campus use, and that the 1939 coupe now used by the Comptroller be assigned for the use of the Superintendent of Maintenance, and further, that the Comptroller be authorized to purchase a coupe for the use of the Comptroller's office.

Buildings and Grounds Repairs - A report of immediately needed repairs in the amount of \$16,666 and desirable repairs in the amount of \$13,300 was presented.

Motion of Mr. Cahlan passed unanimously that the report be accepted and that the Comptroller be authorized to proceed with the work as the funds become available and with the approval of the Chairman of the Regents Committee on Buildings and Grounds.

Library - In view of the fact that the Library fee has been increased from 50 cents to \$2.50 per semester and the Library is in need of repairs.

Motion of Mr. Hilliard passed unanimously that the income from the Library fee be earmarked for repairs and improvements in the Library and that the work proceed as rapidly as possible, under the supervision of Librarian Hill.

#### Architect Fees

(a) Motion of Mr. Cahlan passed unanimously that claims of Russell Mills, Architect, for \$300 for services on plans

for Clark Field Housing Project, and for \$200 for architectural service in connection with temporary Classroom buildings, be approved, and that the Comptroller be authorized to draw checks in payment of above claims.

(b) Claim of Edward S. Parsons was presented in the amount of \$10,000 for architectural drawings and specifications for the Classroom building. Under terms of the original agreement, \$3,500 had been paid, leaving \$7,000 due.

Motion of Mr. Cahlan passed unanimously that the Comptroller be authorized to get an opinion from the Attorney General concerning payment to Mr. Parsons of the additional \$3,500 as authorized by the 1947 Legislature.

# State Records

Agreed unanimously that the Comptroller be authorized to get an opinion from the Attorney General as to the length of time State records must be kept.

- (1) that, effective July 1, 1947, Professor F. W. Wilson be named as Professor of Animal Husbandry and Chairman of the Department of Animal Husbandry at a salary of \$5400 for the academic year of 9 months and that, in addition, he be appointed as Animal Husbandry Specialist to work in conjunction with the Agricultural Extension Division at a salary of \$500 per year to be paid in two monthly installments during the Summer Session;
- (2) that, effective July 1, 1947, Professor V E. Scott be appointed as Director of Residence Teaching in the College of Agriculture at a salary of \$5640 for the calendar year of 12 months service.

Hoskins, be retained on a part-time basis as Dispensing Clerk for the Chemistry Department at a salary of \$80 per month, effective July 1, 1947.
