

Executive Summary

Review/Watch List Discipline

The Review List and Watch List are tools to assist the Committee in evaluating the Plans' investment options. The Committee will examine each of the Plans' investment options on a regular basis to ensure that the investment performance, style, and other relevant investment criteria are acceptable, given the purpose of each investment alternative. The quantitative and qualitative factors of the Review List are described below and include long-term (five-year) performance criteria and qualitative factors so that the investment options can be effectively evaluated on an ongoing basis.

Quantitative Factors

Investment performance will be evaluated on an annualized, trailing five-year period, measured on a rolling quarterly basis. Evaluation criteria will be based on the following:

Actively Managed Portfolios (net of fees)

- Asset Allocation Funds: Underperformed the benchmark
- Fixed Income: Underperformed the benchmark *and* ranked in bottom 50% of peer group
- Equity: Underperformed the benchmark *and* ranked in bottom 50% of peer group

Passively Managed Portfolios (net of fees)

- Asset Allocation Funds: Underperformed the benchmark by an annualized 0.2%
- Fixed Income: Underperformed the benchmark by an annualized 0.1%
- U.S. Equity: Underperformed the benchmark by an annualized 0.2%
- International Equity: Underperformed the benchmark by an annualized 0.3%

Qualitative Factors

The objective of qualitative factors is to identify events that could materially affect the management of the portfolio or the Committee's confidence in an investment option. The Committee and the consultant will work together to determine the materiality of an event. Specific events may include, but are not limited to, the following:

- Significant organizational issues;
- Adverse change in portfolio management talent;
- Lack of adherence to stated investment philosophy and objectives; and
- Uncompetitive investment fees.

An investment option that fails to meet its quantitative performance factors or any of the qualitative factors will be placed on the Watch List. An investment option goes on the Watch List with a Yellow designation when it has failed to meet its objectives for two consecutive quarters. An investment option goes on the Watch List with an Orange designation when it has been on the Yellow Watch List for two consecutive quarters. An investment option goes on the Watch List with a Red designation when it has been on the Orange Watch List for two consecutive quarters. Investment options repeatedly or consistently on watch may be candidates for replacement. An investment option will be removed from the Watch List after exceeding its quantitative performance factors and/or upon the satisfactory resolution of its qualitative factors for two consecutive quarters.




