**1. BUDGET REDUCTION ALTERNATIVES INFORMATION/ACTION**

The Board will consider reports from the Chancellor, NSHE Presidents and the System Administration staff concerning potential strategies to achieve the budget reductions mandated by Governor Jim Gibbons. A number of options will be discussed for budget reductions including a temporary suspension of the Board's policy on the use of Capital Improvement Fee funds generated by student fees (*Title 4, Chapter 10, Section 11*) for the current biennium only so that those funds may be used to supplement operating shortfalls resulting from the required budget cuts. In addition, the discussion will include a review of various options for budget reductions including, but not limited to, one-shot dollars, capital, merit funds, and other campus-specific reductions. The Board may also consider and take action on revenue enhancements to address state reductions, including but not limited to a campus-specific student surcharge. Certain items, including a student surcharge, may require Board approval to go to the Interim Finance Committee for authorization to expend such funds. Based on the discussion, the Board will issue directions or grant authority in relation to steps to be taken to reduce the state-supported budgets of the NSHE institutions and the System Administration ([Ref. A](#)).

The Chair of the Board of Regents may place reasonable limitations as to the amount of time individuals may address the Board.
