5. CANDIDATES FOR THE POSITION OF CHIEF OF STAFF AND SPECIAL COUNSEL TO THE BOARD OF REGENTS FOR POSSIBLE ACTION

At the September 18, 2015, meeting, the Committee charged Committee Chair Kevin J. Page, in consultation with Committee staff, with bringing at least three and not more than 10 semi-finalist candidates, and ideally seven to 10 semi-finalist candidates, to the Committee for review and consideration. The candidates will be identified and the resumes and related materials of the candidates will be presented for review and consideration by the Committee. Copies of each candidate's materials will be made available at the meeting. The Committee may ask questions of candidates via telephone during the Committee's review and consideration of resumes and related materials.

The Committee will discuss and assess the semi-finalist candidates and may take action to select finalists for the position of Chief of Staff and Special Counsel to the Board of Regents.
