**8. REVISION TO PRELIMINARY FOR POSSIBLE ACTION
AFFILIATION AGREEMENT,
UNLV SCHOOL OF MEDICINE AND
UNIVERSITY MEDICAL CENTER**

Dr. Len Jessup, President, UNLV, requests approval of the Second Amendment to the Preliminary Affiliation Agreement between UNLV and University Medical Center of Southern Nevada ("UMC"), which was approved by the Board of Regents in June 2016. The Preliminary Affiliation Agreement provides the framework for an academic health care center that integrates the expertise of the UNLV SOM with the resources of UMC and establishes protocols for an expanded partnership in areas such as graduate medical education, research, clinical medicine, and technology. The Second Amendment to the Preliminary Affiliation addresses issues related to (a) residency programs, (b) hospital credentialing and faculty appointments, (c) payment for professional services, and (d) the use and access of UMC's electronic medical records program.
