Based on the Committee's recommendation, the Board of Regents will consider the approval of the recommended individual to be Chancellor of the Nevada System of Higher Education. The proposed salary and contract terms may be discussed, negotiated and considered for approval at the meeting. If the Board determines not to appoint a nominee recommended by the Committee, the Board may direct the Committee to continue the search process and to recommend an additional nominee or nominees for consideration by the Board of Regents at a future meeting.
