3. PROCEDURES AND GUIDELINES MANUAL REVISION, DISTRIBUTION OF STUDENT REGISTRATION FEES, ACADEMIC YEARS 2019-20 AND 2020-21

FOR POSSIBLE ACTION

Chief Financial Officer Chet Burton and the institution presidents request approval for the distribution of student registration fees for Academic Years 2019-20 and 2020-21 (*Chapter 7, Section 17*). The majority of the student registration fee revenue collected by each institution is used to support the State Supported Operating Budget for each institution. The remainder of the student registration fee revenue is retained by the institution to provide for student access, as well as other institutional and student-related needs including General Improvement, Capital Improvement and student associations. Student registration fees that are part of the State Supported Operating Budget are a key component of the NSHE budget request that is due to the Governor's Finance Office by August 31, 2018. The Board has requested that, after consultation with students, the institution presidents present to the Board at the special meeting in October 2018 their plans for using the 4 percent increase in registration fees approved by the Board in June 2018. FISCAL IMPACT: Revenue associated with the distribution of the registration fee will be reflected in the State Supported Operating Budget as well as various Self-Supporting budgets.

4. 2019-21 BIENNIAL OPERATING BUDGET, SUPPLEMENTAL FUNDING REQUEST AND NEW PERFORMANCE POOL TARGETS

FOR POSSIBLE ACTION

In response to questions raised at the June 2018 meeting, the Board will review an explanation prepared by System Administration staff detailing the calculations relating to the formula calculations and budget formulation in order to provide clarification as to the process and rationale for the budget numbers. To finalize the budget submission, the Board will review and consider approval of a proposed letter to the Governor relating to the NSHE supplemental funding request for the 2019-21 operating budget. It is planned that the letter will be jointly sent by the Chairman of the Board of Regents and the Chancellor to the Governor. The supplemental funding letter and attachments lay out a plan for addressing the faculty salary compression and equity issue as well as prioritizing eight requests for non-formula budget enhancements for four NSHE institutions if additional funding becomes available. The final piece of the budget process is resetting the NSHE performance pool target recommendations that were agreed upon by the Performance Pool Working Group earlier this year. The targets will set the goals for the performance pool carve-out for years 7 and 8 of the program.

This agenda item is the final part of the Board's review and approval of the 2019-21 NSHE budget request. The Board is asked to provide final approval of the budget request to the Governor including the base, maintenance and enhancement components of the budget. This approval includes the supplemental funding request that will be submitted to the Governor, as well as the revised performance pool targets. (*Ref. BOR-4*)

FISCAL IMPACT: The NSHE State Supported Operating Budget is the primary source of funding for all NSHE institutions and Board review and approval is required prior to final submission to the Governor's Finance Office by the August 31, 2018, deadline.
