# 2. LAS VEGAS STADIUM JOINT USE AGREEMENT, UNLV

### **INFORMATION ONLY**

Chancellor Thom Reilly and UNLV President Len Jessup will present for information and discussion a draft of the proposed Joint Use Agreement (JUA) between UNLV and the LV Stadium Events Company, LLC (the Raiders stadium operating company) governing UNLV's use of the future Las Vegas Stadium. Chancellor Reilly and President Jessup will outline the terms of the draft JUA and provide information about the negotiation process. This meeting is the first of a two-part process. The Board may ask questions, provide feedback and give general direction concerning the JUA. It is anticipated that a final version of the JUA will be presented for the Board's consideration and possible approval at a special meeting of the Board on January 19, 2018. (*Ref. BOR-2*)
