#### 7. HEALTHY NEVADA PROJECT

#### **INFORMATION ONLY**

Dr. Joe Grzymski, Director of the Desert Research Institute Applied Innovation Center, will present an update on the Healthy Nevada Project, a partnership between Renown Health and DRI initiated in 2016 to provide a more comprehensive approach to help Nevada address some of its most complex environmental health problems. With the formation of the Renown Institute of Health Innovation (Renown IHI), the study will help DRI, Renown Health and Nevadans begin to understand how environmental factors and genetics can help predict who may be at risk, allow for quicker diagnoses, and encourage the development of more precise healthcare treatments. The goal of the Renown IHI is to build a large health determinants database that captures data on these determinants, which include behavior and socio-economics, as well as the care received, genetics and environmental determinants. The presentation will include an update on the pilot phase of the program (September 15, 2016, to December 31, 2017) under which northern Nevada residents were offered the opportunity to volunteer for research and gain access to individual genetic information free of charge.
