**1. AGENDA ITEM TITLE:** University of Nevada, Reno – Naming of New and Existing Buildings

**MEETING DATE:** June 7 – 8, 2018

**2. BACKGROUND & POLICY CONTEXT OF ISSUE:**

In July 2017, the Facilities Services Planning and Construction (P&C) Department was relocated from its space in the Facilities Services Building due to the discovery of radium in the building. The radium residual was caused by experiments conducted in the building in the 1950s.

Resulting from this displacement of approximately 35 people, a series of space relocations and renovations was undertaken to re-organize and optimize space assigned to the Facilities Services Department. As part of the space re-organization the following occurred:

1. Several personnel were moved from the existing Facilities Maintenance Services (FMS) Building
  - Paint Shop relocated to a new modular shop at Valley Road
  - Electric Shop relocated to a new modular shop in the north part of campus
  - Carpenter Shop and Human Resources/Safety relocated to an existing Custodial modular building
2. The FMS Building was renovated to house the Facilities Services leadership, FMS leadership, and the entire P&C staff (approximately 45 people).

This request is to name the two new modular spaces and change the names of the Custodial Building and the FMS Building to reflect the new occupants. See attached for full detail. (Exhibit 1)
