Continued Financial Aid Eligibility for Title IV Funds through the Program Participation Agreement (PPA)

What is the Purpose and Scope of the PPA?

- To participate in the Federal Student Aid (FSA)
 programs, a school must have a current Program
 Participation Agreement (PPA) signed by the school's
 president.
- With the PPA the school agrees to comply with the laws, regulations, and policies governing the FSA programs.
- The PPA provides the effective date of a school's approval and the date by which the school must reapply for participation.

Reapplication for CSN

- CSN reapplied for Certification to the PPA on March 31, 2015.
- Eligibility for financial aid is extended by the U.S.
 Department of Education until they review and respond.
- The PPA is closed at this time to the school for any changes or additions of new programs.

Reapplication for CSN

- Received letter from NWCCC on May 11, 2016 new programs approved for CSN.
- Awaited response on the Reapplication for Title IV aid until February 2018.
- Contacted DOE requesting action on closed PPA.
- Received response from the Department of Education on February 9, 2018, that CSN was granted Provisional Certification to participate in Title IV, HEA programs until March 31, 2019.
- Required to reapply for the PPA by December 31, 2018.

Special Requirements for Substantial Changes Made during Term of Provisional Certification

• Any institution provisionally certified must apply for and receive approval by the Secretary for program expansion or any substantial change (as hereinafter identified) before it may award, disburse or distribute Title IV, HEA funds based on the substantial change. Substantial changes generally include, but are not limited to: (a) establishment of an additional location; (b) increase in the level of academic offering beyond those listed in the Institution's Eligibility and Certification Approval Report (ECAR); or (c) addition of any educational program (including degree, non-degree, or short-term training programs).

Special Requirements for Substantial Changes Made during Term of Provisional Certification

• If the Institution applies for the Secretary's approval of a substantial change, the Institution must demonstrate that it has the financial and administrative capability necessary to assure the Institution's continued compliance with the standards of financial responsibility (34 C.F.R. 668.15) and administrative capability (34 C.F.R. 668.16).

Reasons Given for Provisional Certification

- New Degree Program at Public or Private Non-profit
 - In addition to the expansions and substantial changes identified above under Special Requirements for Substantial Changes Made During Term of Provisional Certification, as a provisionally certified public or private non-profit institution, the institution must also apply for and receive approval by the Secretary for the addition of any degree programs.

Reasons Given for Provisional Certification

- Gainful Employment Transitional Certification
 - The institution failed to comply with the Gainful Employment (GE) regulations at 34 C.F.R. § 668.414, which required institutions that offer one or more gainful employment programs to submit to the Department of Education (the Department) a GE Transitional Certification no later than December 31, 2015. College of Southern Nevada submitted the required GE Transitional Certification on April 4, 2016. This failure of adherence to regulatory requirements is reflective of the institution's lack of administrative capability.



Immediate Action

February 2018

- In response to notification, CSN was asked to complete the following steps:
 - Print two copies of Program Participation Agreement (PPA).
 - Secure CSN president's signature on both copies.
 - Submit both copies with original signatures.

Actions Completed

- CSN Financial Aid transferred to Student Affairs effective January 1, 2017.
- March 12, 2018 the Program Participation Agreement (PPA) was opened by the Department of Education (DOE) for CSN to add new President.
- March 12, 2018 CSN updated the President name to reflect Acting President, Dr. Margo Martin.
- March 14, 2018 the Program Participation Agreement (PPA) was reopened again by the Department of Education (DOE) for CSN to add additional changes that occurred between the time CSN submitted the original PPA and the time the DOE granted Provisional Approval.
- CSN Added 8 new Programs to the PPA on March, 15, 2018, and is awaiting approval from the DOE.
- April 6, 2018 CSN complied with the Gainful Employment Transitional Certification.

Pending Items

- The DOE notified CSN on April 24, 2018, that the submitted new programs for approval have been approved and that CSN will receive an updated letter soon.
- The DOE notified CSN that the college can submit the PPA recertification as early as 6 months prior to expiration date of March 31, 2019.
- CSN will submit Application for Recertification in September 2018 with all supporting documentation.
