2. BACKGROUND & POLICY CONTEXT OF ISSUE:

Pursuant to Title 4, Chapter 17 et. seq. of the NSHE Regents' *Handbook*, on a biennial basis, the Board requests that proposals for future tuition and fees for the professional schools be reviewed.

Upon recommendation by the school, and approval by the UNLV President, a proposal for 2019-2021 tuition and fees for the UNLV William S. Boyd School of Law has been finalized for Board consideration.

It should be noted that the Law School uses the same fee structure for Summer as the previous Spring. Attached hereto as reference material is a document providing detailed background information in support of this recommendation.

3. SPECIFIC ACTIONS BEING RECOMMENDED OR REQUESTED:

The University of Nevada, Las Vegas presents for final approval the proposed 2019-21 biennium tuition and fees for the UNLV William S. Boyd School of Law in accordance with *Procedures and Guidelines Manual* Chapter 7, Sections 5 and 20, which were previously discussed at the March 1-2, 2018, meeting of the Board.

UNLV William S. Boyd School of Law Student Registration Fees and Non-Resident Tuition for the 2019-21 Biennium June 7-8, 2018

I. Registration Fee and Non-Resident Tuition

The UNLV William S. Boyd School of Law will not raise registration fees for the 2019-21 biennium. Registration fees were last increased in FY17 by approximately 4% to \$25,900/year for residents and \$37,800/year for nonresidents. Part-time tuition and fees was increased to \$926 per credit for residents and \$1,350 per credit for nonresidents. This increase is close to the median increase over the past five years for the thirteen law schools in our peer group, listed in Figure C. The law school is ranked sixth lowest out of these peer institutions for resident tuition cost, 5% below median, and fifth lowest for non-resident tuition, 10% below median. The nationwide trend in law school enrollment continues to decline so it is critical that the law school remain competitive on pricing while maintaining student guality. An increased portion of fee revenue is allocated to scholarships to support recruitment but as there is limited ability to raise the tuition rates, these costs are absorbed by cost reductions in other categories as well as new revenue streams from the LL.M program implemented in FY16 and by fundraising.




Figure C: Peer Tuition and Fees

Figure D: Enrollment - Actual & Projected





Figure E: Law School Applications
