5. CSN INNOVATIVE INITIATIVES

Representatives of CSN will present a report on multiple efforts underway to further improve student success. CSN has been recognized by Governor Sandoval's Office of Science, Innovation and Technology (OSIT), as well as the Nevada Department of Education (NDE), as an innovative incubator willing to research, develop and launch initiatives that address barriers facing minority and underrepresented students, promoting access, recruitment, persistence, retention and completion among the at-risk, first-time-in-college (FTIC) students whom CSN serves. In the past few months, CSN has been invited to participate in four distinguished funding opportunities. The CSN team is excited to highlight these recently-awarded grant initiatives: Lumina Talent Hub, Complete College America, OSIT STEM, and the Nevada ACE. ([Ref. CC-5](#))
