#### 3. CONSOLIDATION OF POLICE SERVICES

### 3.1 IACLEA POLICE CONSOLIDATION REPORT

**INFORMATION ONLY** 

Chancellor Thom Reilly and Vice Chancellor Nate Mackinnon will provide an overview of the work that has taken place since the September 2017 Board meeting on consolidating police services at the southern Nevada institutions. As part of this overview, representatives from the International Association of Campus Law Enforcement Administrators (IACLEA), who provided expert analysis for the NSHE, will present their report and findings to the Board. ### 3.2 ANALYSIS OF NORTHERN NEVADA POLICE SERVICES AND WNC

**INFORMATION ONLY** 

UNR Assistant Vice President and Director of University Police Services Adam Garcia will present an analysis and update for merging the public safety functions between WNC and University Police Services. (Refs. BOR-3.2a, BOR-3.2b and BOR-3.2c)

FISCAL IMPACT: It is estimated that merging the public safety function and police services at WNC will cost the college approximately \$50,000 annually. However, the merger will include reinstituting the Western Nevada Peace Officers Academy, which will be operated under the auspices of University Police Services. This is expected to generate approximately \$70,000 annually for WNC, which would net a gain of approximately \$20,000 annually once fully implemented.

### 3.3 SOUTHERN NEVADA POLICE CONSOLIDATION

#### FOR POSSIBLE ACTION

CSN President Federico Zaragoza and UNLV Acting President Marta Meana will each provide an update on steps taken at their institutions since the IACLEA report was released in April 2018. The southern institutions will then provide a timeline for moving forward to full consolidation. The Board will consider approval of the consolidation of police services in southern Nevada in accordance with the Memorandum of Understanding and proposed timeline. (Refs. **FISCAL IMPACT:** It is anticipated that the consolidation of police services among the southern institutions will produce savings that cannot be estimated at this time.
