6. HANDBOOK REVISION, STATEMENT OF FOR POSSIBLE ACTION
INVESTMENT OBJECTIVES AND POLICIES
FOR ENDOWMENT FUND AND OPERATING FUNDS

Chief Financial Officer Andrew Clinger requests approval of the proposed revisions within the Statement of Investment Objectives and Policies for the Endowment Fund (*Title 4, Chapter 10, Section 5*) and the Statement of Investment Objectives and Policies for the Operating Funds (*Title 4, Chapter 10, Section 6*). The policy revision adds the Nevada System of Higher Education goals to the Investment Policy Statements and changes the definition of the Operating Funds, Short-Term Pool, Intermediate-Term Pool and Long-Term Pool to allow NSHE staff to determine the appropriate reserve level. The policy revision also delegates authority to the Chief Financial Officer to approve the termination of investment managers under certain conditions and approve investment rebalancing recommendations made by the investment advisor.
