2. BACKGROUND & POLICY CONTEXT OF ISSUE:

Board of Regents Handbook, Title 4, Chapter 14, Section 3.2 states:

"Institutional strategic plans and mission statements for each NSHE institution, including the Desert Research Institute, shall be presented for consideration to the Board of Regents at least every seven years and will cover a planning period of up to seven years. Updates concerning progress toward major goals and the revision of existing goals may come before the Board at any time during the seven year planning period as determined appropriate by the institution."

The Western Nevada College (WNC) 2019-2025 Strategic Plan was completed as a collaborative and inclusive community process between August 2017 and January 2019. It is the first Strategic Plan in Nevada created under and in alignment with the new Nevada System of Higher Education (NSHE) goals. Additionally, this Strategic Plan reflects the shift within the Northwest Commission on Colleges and Universities (NWCCU), our regional accrediting body, toward more streamlined strategic plans with focused Key Performance Indicators at the institutional level. Annual strategic planning across all academic programs and administrative offices allows for clear goal alignment with this institutional plan and improves the College's ability to track and assess nimble initiatives that respond to the changing needs of the students and communities we serve.

As a result of the guidance from NSHE and NWCCU, and under the direction of our WNC community input, the WNC 2019-2025 Strategic Plan takes on an innovative structure and leaner format that captures the heart of our ongoing mission and goals. The proposed policy revision would update WNC's mission statement accordingly in Board policy.

President Solis requests Board approval of a *Handbook* Revision to Title 4, Chapter 14, Section 4 to reflect Western Nevada College's revised mission statement.

The impetus for this request is not only to comply with Board Policy Title 4, Chapter 14, Section 3 regarding presenting for consideration an institutional strategic plan and mission statement to the Board of Regents at least every seven years, but also to ensure WNC meets the expectations of its accrediting body, the Northwest Commission on Colleges and Universities.
