2. BACKGROUND & POLICY CONTEXT OF ISSUE:

The Board of Regents of the Nevada System of Higher Education Security Committee has requested a summary of preparations leading up to and immediate actions taken following the explosion at Argenta Hall on July 5, 2019. Amanda Windes, Manager Organizational Resilience and Todd Renwick, Interim Chief, University Police Services will make a presentation on behalf of the University of Nevada, Reno.

3. SPECIFIC ACTIONS BEING RECOMMENDED OR REQUESTED:

University of Nevada, Reno President Marc Johnson, through Amanda Windes, Manager Organizational Resilience and Todd Renwick, Interim Chief, University Police Services presents information regarding the University of Nevada, Reno emergency preparation, and immediate response and support efforts provided regarding the July 5, 2019 explosion.

4. IMPETUS (WHY NOW?):

The July 5, 2019 explosion at Argenta Hall spurred a large multi-agency response that resulted in a City of Reno Emergency Declaration and formal resource requests from the State of Nevada to stabilize the situation. The University of Nevada, Reno has put in place comprehensive emergency management systems/preparations that were immediately enacted during this event.

6. BULLET POINTS TO SUPPORT REQUEST/RECOMMENDATION:

Pre-Incident Preparation Ramifications

- Staff/Student preparedness training and evacuation drills resulted in timely lifesaving response to the emergency situation.
- University Police Service participation in mutual-aid agreements, preparations, and interoperable communications with Northern Nevada response agencies provided immediate integration with other response agencies to save lives and protect property.

- Organizational Resiliency all-hazard planning, preparations preparedness, and full integration
 with Regional Partners as a signatory to the Washoe Regional Emergency Management Plan
 ensured successful emergency management.
- Pre-established relationships with mutual-aid partners facilitated an effective immediate response.

Immediate Incident Response

- Adherence to incident command system resulted in rapid establishment of command and control of the incident.
- Engaged in interoperable communications with mutual-aid partners critical for situational awareness and coordination.
- Utilized Regional Dispatch model, which allowed for immediate deployment of assets and resources ensuring rapid mutual-aid assistance for expanding incident, equipment tracking, and agencies responding with a massive increase in radio traffic and call volume.

Incident Support

- Engagement and previous training of the University of Nevada, Reno Issues Management Team, including FEMA courses, provided strategic oversight needed to support the onsite responders.
- Experience and training of the University of Nevada, Reno Issues Management Team resulted in the identification, prioritization, and management of additional issues resulting from the crisis.
- Continuity-of-operations planning, exercises, and formal training by the University of Nevada, Reno Issues Management Team provided succession plans to maintain leadership and authority as well as establish alternative operations to maintain essential functions.
- The University of Nevada, Reno Issues Management Team transitioned the incident from unified emergency-response efforts to Student Services and Facilities Services for recovery efforts.

Argenta Incident

- July 5, 2019, approximately 1 p.m.
- Explosion in boiler room of Argenta Hall triggering an automatic fire/police response due to activation of fire suppression system
- Approximately 10-12 minutes later massive explosion occurred
- Regional mutual aid and mass casualty plan were activated
- Over 21 agencies responded

- Transition of leadership




Interoperable Communications
