2. BACKGROUND & POLICY CONTEXT OF ISSUE:

Background

The existing Liberal Arts and Sciences Building on campus was constructed in 2008.

Request

Nevada State College requests that the current Liberal Arts and Sciences Building be named the "Robert and Sandy Ellis Liberal Arts and Sciences Building". The Ellis's are strong advocates of the institution. Robert and Sandy have been donors to Nevada State since 2004 and are passionate about the College. A long-time supporter of his hometown, Bob and Sandy were recognized by the Henderson City Council in 2009 for their support of the College, and CCSD schools. They were named Distinguished Nevadans by the Nevada System of Higher Education in 2015.

K-12 education is another passion. They have been involved at nearly a dozen CCSD schools, provided holiday presents, financial contributions to the schools, and basic supplies for students. In 2018, they were recognized for their efforts with the opening of the Robert and Sandy Ellis Elementary School.

The Ellis's received the President's Medal from the College in 2011. The building name was selected based on a contribution to the College from Robert and Sandy.
