MEETING DATE: May 8, 2020
2. BACKGROUND & POLICY CONTEXT OF ISSUE:
Every two years, the Nevada System of Higher Education (NSHE) produces an inventory and utilization report, referred to as the Space Study, which has been designed to provide the Board of Regents with credible, auditable, and meaningful space reports to support future capital planning and budgeting cycles.  The Space Study includes an inventory of assignable space and a space utilization report. The major components of the space inventory include:  The current inventory of all spaces owned and leased by NSHE institutions  Space predictors to determine the amount of space needed for classrooms, class labs, faculty office, research facilities, and study spaces for the current reporting period and ten years from now  An "exception report" allows institutions to clarify the extent to which surplus space may be targeted for renovation or reconfiguration to better meet the needs of the institution
<ul> <li>The major components of the space utilization report include:</li> <li>Data on classroom and class lab use and capacity during a 98-hour week (from 8 a.m. to 10 p.m., seven days a week)</li> <li>Room use and capacity for non-traditional courses, such as short term, modular, continuing education, and industry sponsored courses; medical and dental facilities; and hybrid classes, such as independent study, webbased, or correspondence courses that require an in-classroom component (i.e. proctored testing)</li> <li>An "exception report" quantifies low-use classrooms and class labs and clarifies the issues associated with the low-use</li> </ul>

Response - The surplus is due to multiple factors. This is the first report that our ABE/ESL classrooms have been included as part of our inventory, which has added space. The average class size at GBC has increased from approximately 12 to 16. Over the last seven years, enrollment in online classes has increased 20-25% per year. In addition, the budget reductions have impacted the number of sections that we have been able to offer and the EIT building was completed at approximately the same time as the reductions in funding started. GBC has two high tech centers that we are funded for 100% of the O&M for those building, however, these are shared facilities in Elko and Pahrump and there are several classrooms that the College has limited or no access to. Since we receive funding for the entire high tech center, all of the space in those buildings are included in the inventory report.
