## 2021 Legislation Impacting NSHE



- SJR 7 Amends the Board of Regents out of the Nevada Constitution
- AB 450 Conduct an interim study to align workforce training offered by community colleges
- SB 287 Designate UNLV, UNR and DRI as land grant institutions
- AB 416 Requires the Legislative Auditor to conduct and audit of NSHE



- SB 128 Directs the State Treasurer to conduct a study concerning the effectiveness of publicly funded scholarships and grant programs
- SB 342 Authorizes the Board of Regents to enter into an agreement to affiliate with a publicly or privately owned medical facility
- AB 254 Authorizes a student athlete to enter into a contract with an organization other than an institution or a national collegiate athletic association that provides for the student athlete to compensated



SB 327 Expands the definition of discrimination relating to race to include ancestry, color, ethnic group identification, ethnic background and traits associated with race, including, without limitation, hair texture and protective hairstyles



SB 347 Establishes various provisions related to Title IX

Prohibits the Board from fixing tuition charges against students who parent, legal guardian or spouse was stationed at a military installation in Nevada and the student graduated from a Nevada High School

Removes the requirement for a Millennium Scholarship recipient to declare US citizenship or lawful immigration status



SB 347 To the extent money is available the Board may prescribe an alternative to the FAFSA

Provides a student is eligible for the Silver State
Opportunity Grant or a Nevada Promise Scholarship if a
student graduated from a Nevada high school
regardless of whether the student is a bona fide
resident

Removes the prohibition of distributing Nevada Promise Scholarship funds to students prohibited from completing the FAFSA



### **Tuition and Fee Waiver Legislation**

AB 156 Authorizes a member of the active Nevada National Guard to assign or reassign a waiver upon reenlistment, regardless of whether the member used a waiver to attend a school within the System before he or she reenlisted

AB 165 Removes the 5-year limitation on assessing tuition changes and instead prohibits the Board of Regents from assessing tuition charges against all veterans that were honorably discharged



### **Tuition and Fee Waiver Legislation**

AB 262 Grants a waiver of registration fees, laboratory fees, and all other mandatory fees to eligible members or descendants of any federally recognize Indian tribe or nation, all or part of which is located within the boundaries of Nevada



### **Tuition and Fee Waiver Legislation**

SB 193 Require the Board of Regents to require each nursing program and program for the education of teachers to give preference in admission to veterans of the Armed Forces of the United States who have been honorably discharged

Prohibits a tuition charge being assessed against veterans, spouses and dependents who are using Post-9/11 Educational Assistance

Prohibits a tuition charge from being assessed against students using Survivors' and Dependents Assistance

### **Workforce and Research**

WINN Fund \$1.5 million appropriation and \$2 million in federal WIOA grant funds

Knowledge \$2.5 million per year appropriation Fund



### Other Bills With State Funding

- SB 310 \$400,000 for CSN to assist and carry out the NV Grow Program
- AB 376 \$500,000 to the Immigration Clinic at the William S. Boyd School of Law
- AB 355 \$750,000 to IFC for allocation to the International Gaming Institute at UNLV
- SB 460 \$213,771 per year to the Cooperative Extension Service for travel and operating costs



### Other Bills With State Funding

AB 495 \$600,000 per year to the Silver State Opportunity Program to restore funding to \$5 million per year



### Financial Aid Programs

#### **Governor Guinn Millennium Scholarship**

- AB 475 \$42 million
- Merit-based scholarship created by the Governor Guinn administration in 1999

#### Silver State Opportunity Grant – \$5 million per year

 Created in 2015 based on a shared responsibility model for awarding grant aid whereby the total cost of attendance (tuition, fees, and living expenses) is shared by partners (the state, feds, family, and the student)

#### Nevada Promise Scholarship – AB 454 - \$7.3 million

 Last dollar program created in 2017 whereby students that complete the FAFSA and meet certain requirements receive a scholarship to cover the base registration fee that is not otherwise covered by state and federal aid

## Transfer WICHE to NSHE

- Nevada is the only western state in the 16-member compact whose WICHE program operates outside the higher education system.
- Program Innovation Operating together allows NSHE to benefit from the latest information available from (regional) WICHE, and allows Nevada's program to respond to unique state workforce needs
- Community Partnerships WICHE regularly partners with NSHE to assist Nevada students. As part of NSHE, WICHE can better access and grow relationships with NSHE professionals
- Sharing of Resources Operational efficiencies through shared resources and systems

### **Budget Related Legislation**

AB 494 Appropriations Act – Allows NSHE to transfer appropriations among the various budget accounts within NSHE upon the recommendation of the Governor and approval of IFC

Did **NOT** include restriction on use of appropriations for professional merit increases

SB 459 Authorizations Act – Allows NSHE to expend additional registration fees and nonresident tuition beyond the amount budgeted and carry forward unexpended balances



### **Employee Compensation**

AB 493 Personnel **NOT** represented by a collective bargaining agreement approved pursuant to NRS 288.555 will receive a 1% cost of living adjustment in FY 23

Personnel represented by a collective bargaining agreement approved pursuant to NRS 288.555 will receive a 3% cost of living adjustment in FY 23



### **Employee Compensation**

AB 493 \$773,459 appropriated to the State Board of Examiners to cover the cost of 1% cost of living adjustment for NSHE classified employees

\$3.6 million appropriated to the State Board of Examiners to cover the cost of 1% cost of living adjustment for NSHE professional employees

Appropriations for the cost of living adjustments for the classified and professional employees of NSHE are based on the proportion of state appropriations to the total revenue within each state supported budget



SB 461 (a) Determine the reduction in State General Fund revenue

(b) Transfer to the State General Fund an amount equal to the amount determined in paragraph a

After the transfer to the State General Fund disburse money from ARPA in the following order of priority



- SB 461 (a) \$335,000,000 to repay advances from the federal government for unemployment compensation
  - (b) \$20,900,000 for the public health emergency of the COVID-19 pandemic
  - (c) \$7,600,000 to address increased levels of food insecurity due to the impact of the COVID-19 pandemic
  - (d) \$6,000,000 to the Collaboration Center Foundation to address the impacts of the COVID-19 pandemic



- SB 461 (e) \$5,000,000 to the State Treasurer to be administered as grants to persons with disabilities
  - (f) \$4,000,000 to UNR to establish a statewide program modeled after the Dean's Future Scholars Program
  - (g) Disbursement of funds for any purpose authorized within the following categories



- SB 461 (1) Increasing access to health care and communitybased services
  - (2) Strengthening public education
  - (3) Supporting disadvantaged communities
  - (4) Strengthening Nevada's workforce, supporting small businesses and revitalizing the State's economy
  - (5) Investing in infrastructure
  - (6) Modernizing and enhancing state govt. services
