3. **EMERGENCY CODE REVISION,** **FOR POSSIBLE ACTION**
EMPLOYEE COVID-19 VACCINE REQUIREMENT

Chancellor Melody Rose and Chief General Counsel Joe Reynolds will present for review and approval an emergency amendment to the NSHE Code (*Title 2, new Chapter 12*) that sets forth policies and procedures to enact a COVID-19 vaccine requirement for all NSHE employees effective December 1, 2021. Failure of an employee to timely comply with the provisions of the Chapter will result in termination, absent an approved waiver based upon a medical condition or religious belief. ([Ref. BOR-3](#))

4. **CODE REVISION, DEVELOPMENT AND** **INFORMATION ONLY**
REVIEW OF SALARY SCHEDULES

Chancellor Melody Rose and Deputy General Counsel for System Administration Yvonne Nevarez-Goodson will present for information proposed revisions to the NSHE Code (*Title 2, Chapter 5, Section 5.5.1*) that would clarify the process and timelines for the Chancellor to develop salary schedules for executives, administrators and faculty of NSHE institutions through input from System-wide stakeholders and retention of an independent compensation expert. The proposed amendments will be presented for action at a subsequent meeting of the Board to be held not sooner than 30 days after the September 30, 2021, meeting, in accordance with Title 2, Chapter 1, Section 1.3.3 of the Code.
