3. EMERGENCY <u>CODE</u> REVISION, <u>FOR POSSIBLE ACTION</u> EMPLOYEE COVID-19 VACCINE REQUIREMENT

Chancellor Melody Rose and Chief General Counsel Joe Reynolds will present for review and approval an emergency amendment to the NSHE <u>Code</u> (*Title 2, new Chapter 12*) that sets forth policies and procedures to enact a COVID-19 vaccine requirement for all NSHE employees effective December 1, 2021. Failure of an employee to timely comply with the provisions of the Chapter will result in termination, absent an approved waiver based upon a medical condition or religious belief. (*Ref. BOR-3*)

FISCAL IMPACT: The fiscal impact is unknown at this time, but an impact is likely.

4. <u>CODE</u> REVISION, DEVELOPMENT AND REVIEW OF SALARY SCHEDULES

The proposed amendments will be presented for action at a subsequent meeting of the Board to be held not sooner than 30 days after the September 30, 2021, meeting, in accordance with Title 2, Chapter 1, Section 1.3.3 of the <u>Code</u>.
